Re: Submission of City of Sacramento's Exhibit List and Exhibits and Objections to DWR's Exhibits DWR-558 and 563

Dear Hearing Chair Doduc and Hearing Officer Marcus:

Consistent with the Hearing Chair's direction on October 27, 2016 for Group 7 to move to admit its evidence by the close of business on November 2, 2016, the City of Sacramento ("Sacramento"), as part of Group 7, moves and hereby submits for admission into evidence exhibits previously identified by Sacramento, as accurately reflected in Sacramento's attached exhibit list, namely Exhibits CitySac-1 through 19, 22 through 30 and 32 through 34. Each of these exhibits has been shown to be relevant and otherwise appropriate for admission into the record. Enclosed for your convenience is Sacramento's Exhibit Index.

On October 28, 2016, Petitioner Department of Water Resources submitted an exhibit list relating to DWR's cross examination of Group 7 witnesses. Though DWR did not explicitly move to enter these exhibits into evidence, should DWR do so or the Hearing Officers be inclined to admit these exhibits into evidence, Sacramento hereby objects to admitting into evidence Exhibits DWR-558 and 563. These two exhibits were presented to expert Bonny Starr on Panel 7 of Group 7 during cross-examination, for which relevance and foundation are lacking. Specifically, Exhibit DWR-558 is an excerpt from a larger document that was only shown to be referenced in Ms. Starr's written testimony (Exhibit CitySac-8) at page 18, footnote 31, with Ms. Starr's written testimony at paragraph 45 referencing the document as work product "commissioned by the CVRWQCB [Central Valley Regional Water Quality Control Board] summarizing the current state of knowledge regarding potential drivers of hazardous cyanobacteria." As to DWR Exhibit-563, again being just a two-page excerpt from what

purports to be Section 8.0 of the 2015 BDCP RDEIR/SDEIS regarding *Delta* air and water temperatures, Ms. Starr's testimony explicitly focused geographically on Sacramento's intake structures on the American River and Sacramento River, with the latter testified to being near the confluence of these two rivers *north* of the Delta.
