## Dear Governor Brown,

I have lived in San Joaquin County for over twenty-five years and I regularly row up and down the Delta waterways. I am opposed to the current water fix plan because I personally know how fragile our current eco-system is in the Delta.

This is a waste of tax payer's dollars and will devastate the water quality and all of the eco-systems that depend on the Delta for survival. We are already fighting a losing battle against the invasive water hyacinth. California is better than this. We can come up with a plan that protects our waterways and environment for future generations and that uses sensible conservation and recycling technologies to resolve California water problems. The Delta is a unique waterway that belongs to the world not just California.

Our tax dollars should be spent more effectively to resolve the State's water problems by the following:

Funding water recycling and groundwater recharging projects statewide that would be billions of dollars less expensive for rate payers than constructing a new version of the Peripheral Canal or major new surface storage dams. Meanwhile, these projects move communities towards water sustainability.

Retiring thousands of acres of impaired and pollution generating farmlands in the southern San Joaquin Valley and using those lands for more sustainable and profitable uses, such as solar energy generation.

Improving Delta levees in order to address potential earthquake, flooding, and future sea level rise concerns at a cost between \$2 to \$4 billion and is orders of-magnitude less expensive than major conveyance projects that are currently being contemplated.

Increasing freshwater flows through the Delta to reduce pollutants so ecosystems and wildlife can be restored.

#### **Long-term water needs**

Many years ago, our elected state and federal officials looked to the future and saw that California was going to be an agricultural and manufacturing powerhouse with resulting major increases in population.

- Increasing storage of existing facilities on every major dam in the state;
- Look to recirculating and reusing waste water in all future construction using a fourtier system much like that currently used in Las Vegas.
- Complete construction of desalinization plants at every major municipality along the Pacific Ocean from San Diego to the Oregon border.

Also, why hasn't the Record with its "power of the press" and responsibility as journalists heeded the call to support major changes to provide water for the future and drop the fantasy of a bullet train and twin tunnels?

# State's latest plan a scaled-down version of more of the same

ith the California State Fair happening almost down the street, last week would have been a good time for Gov. Jerry Brown to head over to the livestock barn.

He surely would have won the grand prize in the "Lipstick On A Pig" competition.

State officials released their latest iteration of the twin tunnels project, the Gov. Brown legacy-fueled boondoggle that would have two gigantic straws (tunnels) suck Sacramento River water beneath the Delta, diverting it to parched — and politically favored — areas to the south.

This 21st-century iteration of the Peripheral Canal plan has a supposed \$15 billion price tag (cost overruns, anyone?). And state officials say the revised plan will be more environmentally friendly and potentially less harmful to the San Joaquin Delta.

Poppycock.

In 9,276 pages — down considerably from the 34,000-page original document in 2013 — state officials danced around the issues instead of truly tackling them.

"They cannot get away from the inescapable fact that taking Sacramento River water under the Delta will exacerbate exiting water quality conditions," Bill Jennings of the Stockton-based California Sportsfishing Alliance said.

There certainly were cosmetic (read: pig/lipstick) changes with the new document, which obviously was targeted to assuage some environmental concerns.

But so much remains the same: The tunnels will be 35 miles long and 40 feet wide and will divert up to 9,000 cubic feet of water per second from the Sacramento River.

State official Mark Cowin, director of the Department of Water Resources, confidently states that the plan would "modernize our 50-year-old water conveyance system and the sustainability of water supply for California."

There is, without question, a huge need for visionary and fair statewide water policies.

The state's most recent efforts, unfortunately, are Strike Two.

Public comment about the Twin Tunnels Lite plan will be accepted through the end of August.

With apologies to swine everywhere, the state's latest can be summed up in one word: "Oink."

## Assembly GOP leader talks policy

Olsen tackles wide range of issues in meeting with Record's editorial board

STOCKTON — From water, to education reform to a full-fledged California State University campus for Stockton, Assembly Republican Leader Kristin Olsen touched on a wide range of topics during a visit Tuesday with The Record's edictorial board.

Olsen, R-Modesto, who represents the eastern portions of San Joaquin and Stanislaus counties at the state Capitol, is in her final two-year term in the Assembly. Elected the minority party's leader by unanimous vote last year, she immediately set out to reorganize the Assembly GOP caucus.

"Any healthy business, any healthy organization has to constantly refine and improve and adjust, and the Assembly Republican Caucus hadremained a static organization for more than 20 years," Olsen said.

"It wasn't healthy, and so we needed to do a lot to align our strategic plans and goals with technology in the year 2015—and with constituents—and that was quite an undertaking," she said, referring to the party's reputation as the "party of innovation, the party of tomorrow."

Olsen explained that she transformed the caucus from a staff-driven organization to a member-driven caucus "so that the people elected by the people of California were the ones leading initiatives,"

She said she was instrumental in launching the San Joaquin Valley Caucus that includes the 14 members of the Assembly and state Senate, both Republicans and Democrats, who represent the Valley's eight counties, describing how important it is to show a unified front — especially on issues as important as water policy — when dealing with legislators from more populous coastal California.

Solving drought-plagued California's water issues is her No. 1 priority. While conservation is absolutely necessary, she said, "no amount of conservation we do will get us out of this problem."

What is needed, she said, is to bring all the stakeholders together and work to increase the water supply through more storage facilities, desalination plants

and recycling.

"We need to get these projects out of the bureaucracy and into construction," Olsen said, taking a practical approach to the balance necessary between economic benefit and the environment.

She also reiterated her opposition to Gov. Jerry Brown's Delta tunnels project, criticizing it as "a failed plan from the beginning. I'm delighted that the feds have concerns. It's time to change course."

No. 2 on her priority list, education reform, drives one of Olsen's guiding principles: "Every California child deserves access to a top-quality education. And most important is the teacher in the classroom."

Noting the state consistently ranks in the bottom quartile for educational performance nationally, Olsen called that "a failure to our children and to our state's long-term economic success."

She said she believes that with adequate state funding, positive changes will be implemented at the local school district level with a major focus on teacher evaluation and tenure. With five school teachers in her immediate family, Olsen gets firsthand accounts from the front lines of education.

"I think we need to professionalize the profession. It's a hard job, and we make it harder and harder and harder on them. We need better teacher training programs," she said, pointing again to national statistics that rank California near the bottom in preparing its teachers for the classrooms of today.

As a co-author of Stockton Democratic Assemblywoman Susan Eggman's bill calling for a feasibility study of a full-fledged California State University campus in Stockton, Olsennoted that the lack of a public four-year university in a city of 300,000 residents poses significant access challenges for thousands of potential students.

À public college in Stockton, Olsen explained, could address many of the community's longterm societal issues such as widespread poverty, rampant crime and poor health that now hinder its ability to achieve economic stability.





Subject: Comments on BDCP/California Waterfix

Dear Sirs:

Portions of the Bay Delta Conservation Plan / California Water Fix, July 2015 (BDCP) were reviewed. Due to the large volume of data and text, it was not possible to completely review the documents and the revisions. The following comments are made after a brief review.

- 1. <u>BDCP Conveyance Facilities</u> The BDCP conveyance facilities of the preferred Alternative 4A for 9,000cfs include three intakes, three sedimentation basins, pipelines, tunnel, intermediate forebay, dual tunnels, pumping plant and revisions to Clifton Court Forebay (Fig. ES-1). The dual-bore 40-foot ID tunnel is approximately 30 miles in length and would be constructed in soft alluvial soils at a depth of 100 to 150 feet. High groundwater pressures exist in the tunnel foundations. Because of the large tunnel diameter, large depth of construction in soft alluvial soils, high groundwater pressures and extensive tunnel length, the precedent of similar construction could not be found in any reference. **Surprise, the project is unprecedented!**
- 2. Lack of Information There is no description for how the twin tunnel bores would be dewatered, or the type, thickness and construction of the tunnel lining. Dewatering the tunnel bore and constructing a liner at 100 ft. depth for 30 miles with high ground water will be difficult. The lack of discussion on tunnel dewatering is a serious omission. How about dewatering the twin tunnels at 150 ft. depth under the San Joaquin River? Water under the tunnel bore, on both sides and on top (San Joaquin River). This construction will be challenging, and appropriate for unplanned "safe haven technology" (App. A Pg. 3-41). There are (1) no cost estimates for Alternative 4A or the other alternatives in the BDCP, (2) no discussions of basis of selection of Alternative 4A as the preferred alternative or (3) construction schedules. This lack of study and information is a prescription for cost overruns and fiscal disaster for the State of California! Surprise again, this lack of information for a project this size is unprecedented! Appears that the BDCP says: "Never mind! Just build it! We need to get Alternative 4A construction started by 2017!"

- 3. <u>2012 Capital Costs</u> The 2012 estimated capital costs for the conveyance facilities was \$14.6B (BDCP Highlights Dec. 2013, Page 86). It is expected that when preliminary design is completed capital costs will significantly increase.
- 4. <u>Dewatering</u> Dewatering the dual tunnel for 30 miles including under the San Joaquin River is a particular challenge. Water sources at the San Joaquin River will be on both sides, below the tunnel and top (San Joaquin River). Alternative 4A alignment crosses under the Mokelumne Aqueduct (EBMUD) and the railroad line on the north side of Woodward Island (Fig. M3-4 Sheet 10 of 15). Both the aqueduct and the railroad are on piles at Woodward Island and could be susceptible to settlement. The Los Vaqueros Pipeline could also be susceptible to settlement. Groundwater levels could be lowered in this area since... "Dewaterng systems would be designed and operated to control seepage pressures in the vicinity of the main bore and the vertical shafts to ensure that excavations remain stable." (App. A Pg.3-42.) Again, there is no description of the method or depth of dewatering in this area or the entire project.
- 5. <u>Tunnel Lining</u> There is a lack of tunnel information. Fig. 3-21 was referenced in the text (App. A, Page 3-40), but not found. Design consideration should be given to possible changed conditions of the 40 ft. ID lining and loading when relining of the tunnels occurs in say 50 to 75 years. (Note that when the liner thickness is included, the TBM diameter could be as much as 50 ft.). These load conditions are necessary for design to reduce the potential for progressive failure of the dual tunnel that will be continually under pressure and then dewatered after 50 to 75 years. Note "reduce the potential," is used since construction of the dual bore 40-foot ID tunnel is unlikely to be perfect, the potential is unlikely to be eliminated. Repair of progressive failure of the 40 ft. ID dual tunnel at a depth of 100 to 150 feet could be prohibitively expensive and require a long time for dewatering and repair.
- 6. <u>Tunnel Repairs</u> Because of high cost, difficulty of repairs, and long construction repair period for repairs due to seismic loadings, consideration should be given to design of the tunnels for the Maximum Credible Earthquake (MCE).
- 7. Pumping Plant Usually a pumping plant (Alternative 4A) would be located at the upstream near the intermediate forebay. The downstream location near Clifton Court Forebay allows the tunnel to operate at lower internal pressures, but the lower pressures increase the potential for soils to enter the tunnel through cracks or reduced thickness of the lining and/or concrete joints. These cracks could be caused by settlement, seismic activity and/or site specific ground conditions. In addition the repair of the pumps at 125 foot depth due to damage from settlement or seismic loadings would be less costly with the pumping plant near the surface than at depth. Consideration should be given to locating the pumping plant adjacent to the intermediate forebay near the ground surface.
- 8. <u>Sedimentation</u> DWR has included sedimentation basins after the fish screens and intakes. The intermediate forebay also will assist in the removal of sediment. If <u>all</u> of the sediment is not removed after the water enters the twin tunnels, a portion of the sediment could accumulate at the lower elevations of the tunnels such as at river and rail crossings (San Joaquin River, etc.). There appears to be at least eight crossings where the elevation of tunnels may have to be lowered to avoid water and pilings of existing aqueducts. Since water velocity in the twin tunnels

is low (<4fps) and zero at times, removal of sediment at resumption of flow may not occur. Sediment that is not removed by flushing action could accumulate gradually at the lower areas and restrict subsequent water flow. Since twin tunnel flow is by gravity, flushing action is unlikely and removal of sediment could require dewatering of the tunnel. This potential sedimentation condition needs to be addressed in the revised BDCP by describing how <u>all</u> of the sediment will be removed and give references to previous studies by others.

- 9. <u>BDCP</u> The BDCP should protect the ecology of the Delta and provide water deliveries to a level consistent with the available water. NEPA and CEQA have set environmental requirements for the Delta water deliveries. The requirements have been modified several times since the SWP was completed in 1970. Clearly, the amount of water to be delivered each year needs to be defined by the environmental conditions. DWR needs to work with EPA, CEQA personnel and USACE to develop the amount of water delivery.
- 10. <u>Diversions at Clarksburg and Water Quality</u> DWR needs to show the data that demonstrate how diversions at Clarksburg improve water quality and environmental conditions in the Delta. For example, if water was diverted at Clarksburg at the Intakes, how much was the salinity reduced or increased at Decker Island? The monitoring point at Emmaton (Decker Island) could be a reasonable location to compare real time and model study environmental data (salinity, etc,) for diverting water at Clarksburg for the Alternatives 2D, 4A, 5A, 9, and existing condition). Other monitoring points should also be evaluated. For example, using the NEPA and CEQA limit (in ppm) for salinity at Emmaton, provide the values for the alternatives and existing condition and comment on the basis for selection of Alternative 4A as the preferred alternative, and the reasons that environmental conditions are improved by diverting the water at Clarksburg.
- 11. <u>Surface Alternatives</u> Note that Alternative 9 was included as a surface alternative in Item 10 for comparison. The inclusion of Alternative 9 is because it is the only surface alternative (that could be found) besides the existing condition. The existing condition should be modified to develop surface alternative(s) to facilitate the transfer of water to Clifton Court Forebay. The development of a surface alternative that has minimal impact on agriculture and the environment could be the preferred alternative.

In the next five to ten years there are at least two tasks for DWR: (1) Work with EPA, CEQA personnel, and USACE to reduce the environmental conditions that are causing risk to the Delta, and (2) Revise BDCP to select a preferred alternative. Both surface and tunnel alternatives need to be considered. Design concepts need to be explained, water deliveries shown, and cost estimates and construction schedules prepared. Expect that the people of the State of California will be allowed the opportunity to vote on the project. I will copy these comments to my state representatives to ensure that we are allowed to vote on the project.



- 1. The property values of 3,000 Delta water users with water rights would be compromised by the change in water quality, quantity and levels that the Tunnel project would cause, making farming even more problematic.
- 2. The report acknowledges a projected increase in "frequency, magnitude and geographic extent" of Microcystis algal blooms in the Delta creating toxic 'cyanotoxins' affecting flora, fauna and the threat of liver cancer in humans.





Governor Brown's water plan to commit to unknown billions of dollars in today's economic climate is unrealistic. Enclosed is a much better plan. It is called the "Fat Levee Plan" authored by the Business Forecasting Center at the University of the Pacific. The cost of implementing this plan would be only a fraction of the Governor's plan. The science is reportedly sound where the governor's plan is not proven. The earthquake danger has apparently been overstated. Pages 1 and 5-8 of this print-out were blank pages and not included.

Farm production in San Joaquin County alone is in the billions of dollars per year. Its' soils are unrivaled. It would be unconscionable to allow them to be deprived of fresh water and damaged by salt water incursion. Additionally, there is a large agricultural supporting infrastructure as well as all of the other industrial, business, recreational and commercial activities including the growing Port of Stockton facilities. Allowing all of the Sacramento River water to flow into the Delta does not mean that sizeable volumes cannot be pumped south. It just means that politically powerful southern interests do not take priority over Delta needs. Preserving fish populations is a consideration, but does not over-ride all else including the singular beauty of one of nature's wonders, the Sacramento, San Joaquin Delta in California.

Also enclosed is an article which appeared in the Letters to the Editor in the August 6, 2012 of The Stockton Record by Dan Bowman Odenweller, an experienced water management official which deserves close attention.



#### LEVEES THAT LIE DOWN: A SOLUTION FOR EARTHQUAKES IN THE DELTA?

Levees in California's Delta have a bad image problem. For several years now, they've been called "fragile," "decrepit," "crumbling," and "doomed." One news story after another warns of a catastrophic collapse from a future earthquake, alongside scenarios showing half the delta under water – quite possibly undrinkable salt water.

The cost of retrofitting these critical structures, meanwhile, is expressed in extravagant terms. "Astronomical," said Phil Isenberg, chair of the Delta Stewardship Council, about the cost of making the levees earthquake safe. Isenberg made the comment most recently during a televised debate on delta dilemmas, but he's said it before, as have others. The accepted wisdom among water wonks in California is that the levees cannot all be repaired sufficiently to save the state from disaster in the event of a "big one." Some openly recommend that the state allow major portions of the delta to go underwater, to the constemation of delta residents who live and farm there.



When levees fail, an inland sea prevails

"Why would anyone want to save them," a state water official was heard to say the other day about the delta levees. "Everyone knows they're doomed."

But what if this public narrative is wrong – or substantially wrong? What if the levees are in better shape than described and – most importantly – can be retrofitted to withstand a big shake?

If this is the case – if most or all of the levees can be built up to withstand an earthquake, magnitude 7 on the Hayward Fault, for a reasonable amount of money – it would change fundamentally the calculus now driving decisions about major new water infrastructure in California.

The time for that kind of reassessment has arrived with publication of the second draft of an economic sustainability plan for the delta, prepared by a team headed by Dr. Jeffrey Michael at the University of the Pacific. Little attention has so far been paid to the draft plan's new information on levees.

That is a mistake.

On page 64, in a chapter devoted to delta levees, the report states unequivocally, "This study concludes that the core Delta levees can be made robust under seismic loadings for a total of \$1–2 billion."

Written primarily by a civil engineer. Dr. Robert Pyke, who is an expert on earthquake preparedness for dams and levees, working under contract here with Sapper West Inc. in Sacramento,

the levee analysis focuses in on 460 miles of agricultural levees that need upgrades, out of a total of some 1,000 delta levee miles.

The cost of making them seismically resistant is cheap, compared to that of building a tunnel around the Delta (\$12–20 billion), or elevating the highways and railways (\$10 billion) or even retrofitting San Francisco's water delivery system from the Hetch Hetchy reservoir (\$4.6 billion), the report explains.

Not only is retrofitting the levees less expensive than other alternatives, but a good bit of the money has already been allocated in bond issues passed by voters in prior years. California's Department of Water Resources (DWR) has been dragging its heels in releasing the bond money, slowing the repair process in an unconscionable way, considering the risks. Officials should have even less of an excuse now, in the light of this new information.

The key to this claim is an enlarged levee that has such a thick landside shoulder that it looks almost flat from the field. It's crest is very wide – 50 feet compared to 16 feet now on some levees –



"Making a levee robust enough to withstand earthquake shaking is a lot simpler than retrofitting or even seismically designing a new building or bridge," said Pyke. "Basically it just takes a wider cross-section and more dirt."

He explained that in an earthquake, the big fat levee would deform a bit, but "it's unlikely that even with high water that you would have a breach." Asked in an interview how he can be sure without data that this kind of construction would resist a breach, Pyke replied, "The earthquake behavior of dams and levees is central to my education and experience. I've been an expert witness in about 20 cases in California and as far as I know, I've never been on the losing side, because I don't make things up. I don't overstate things."

In any case, he added with a smile, "It's hard to see how the levee can fall over when it's already lying down."

Pyke's claim to expertise is backed up by other civil engineers he's worked with on multiple projects in the state. "He's very, very good – one of the best," said Ed Idriss, retired UC Davis civil engineering professor who worked with Pyke on a four-man team to evaluate potential ground motion from an earthquake for the new East Bay Bridge.

"In terms of knowledge, I'd put Bob Pyke way up there. He's one of the most qualified to look at the effects of earthquakes on levees." Idriss served on the Seismic Safety Peer Review Panel for the new bridge.

If the new report is true, however, it raises a sticky question: How did so many other experts on the delta get it wrong for so long? The answer appears to lie in a controversial, but nonetheless influential, report put out in 2005 by the DWR. Titled "Delta Risk Management Strategy,", phase 1, the DRMS report made highly sophisticated calculations of levee failure in the event of an earthquake, estimating that up to 50 breaches could occur, flooding 20 islands and disrupting the state's water supply to 23 million people. Such estimates were not based on new data on actual levees, and little has been collected since. In fact, there are gaping holes in bare facts, such as how much loose sand lies under existing structures. No one knows.

According to Pyke, lack of basic facts leads to inaccurate predictions. "The data was just not there to do such advanced calculations," he said. "If you lack adequate data in a study like that, it leads to greater uncertainty. Greater uncertainty pushes up the mean results. It's inescapable and very

ADDTHIS Share I common. I caution people not to rush into risk and probability analysis unless you have enough data to do it accurately."

Nevertheless, the DRMS study became the basis of more calculations and more analysis by scientists at UC Davis and UC Berkeley who expanded the earthquake predictions into a full-fledged story of levee collapse - still with no new information on how the levees are actually constructed

To make matters more complicated, there's every reason to be concerned. The hundreds of miles of levees that surround about 70 islands are highly variable, ranging from good to very poor. They've been unevenly maintained; they are made from different materials; some would probably breach in an earthquake if not improved as soon as possible

"These levees are the poor stepchild - the one critical feature in California that is still being neglected (for seismic upgrades)" said Pyke, noting that Cal Trans and public utilities in the East Bay and San Francisco have spent billions to upgrade their infrastructure. But levee repair is lagging, even though voters have twice voted for money to fix them

Many would argue that the delay can be traced to the state's preoccupation with building a multi-billion dollar "isolated conveyance" (aka, peripheral canal). If the levees can be retrofitted for earthquakes, one good reason for building the canal

would be lost, and wealthy interests in the state want the conveyance - actually a tunnel under the delta.

Conspiracy or not, it's clear there is a powerful constituency, highly influenced by work done by UC Davis scientists at the Public Policy Institute of California, to write the levees off – or many of them.

Based on this new report, ordered by the Delta Protection Commission, there should be a powerful constituency now to build them up. At the very least, state planners need to reverse gears and not let them waste away.

Much of this conflict is more contrived than real. The UC Davis and PPIC folks have always said that many (but not nearly all) Delta levees are worth repairing, and that significant levee repairs will be needed until more permanent Delta solutions are in place. In the long run, even if levee retrofitting was free and perfect, sea level rise, increasing drinking water standards, and endangered species problems will continue to drive urban and agricultural water users from direct Delta supplies

I am writing to provide some personal background and perspective on the issue of water development and the Delta. I bring a unique perspective to the table since I came to Stockton as a biologist for the California Department of Fish and Game in 1974. At the time, I had a one year contract to conduct studies and serve on an interagency team developing the fish screens for the peripheral canal.

In the late 1970s, I became the department's (and a state) spokesman on the peripheral canal, and a strong supporter of the package of legislation put together by Assemblyman Larry Kapiloff, which was defeated by the voters in 1982. Thirty years later, I still believe it has technical merit.

However, in the interim 30 years I have witnessed repeated violations of permit terms and conditions by both the federal Central Valley Project and the state water project. These violations were knowingly committed and have not resulted in penalties like those we imposed on waste discharge permit violators during my tenure as a board member of the Central Valley Regional Water Quality Control Board. In short, I no longer can support this solution because government has proven it cannot be trusted.

One need only look at the current process to shudder at the potential outcome. I remember the letter from the two water projects to the state Water Resources Control Board at the start of the last recent drought year, to see our future.

Absent an on-off switch for the Delta pumps in the offices of John Herrick, Dan Nomelini, Tom Zuckerman and Bill Jennings, we should simply say no!

## Subject: Oppose the Delta Tunnels/California Water Fix (Alternative 4A)

I am writing to let it be known that I totally oppose the Delta Tunnels/California Water Fix (alternative 4)A. The so called fix, is neither in the public's interest, nor the public pocketbook. A few will benefit at the expense of many. It has been pushed through without public vote, as the people have voted this idea down already twice. It will be more likely to cause earthquakes than prevent them. It will not create new water, nor will it protect the environment, thereby failing to fulfill the coequal goals which it portrayed as fulfilling.

The Delta Reform Act of 2009, in which the California State Legislature committed to the "coequal goals" of providing a more reliable water supply for California AND protecting and restoring the cultural, recreational, natural resource, and agricultural values of the Delta, cannot be upheld if the Delta Tunnels come to pass.

The California Water Fix does not meet the restoration goals of the Delta Reform Act; it is simply a plan to export more water out of the San Francisco Bay-Delta estuary. The Delta Tunnels will also fail to provide more reliable water because the Delta watershed is already oversubscribed by five times in normal water years.

## My objections to the tunnels are threefold:

The California Water Fix does not address the environmental, public health or economic impacts of the proposed Delta tunnels project. Also, the plan ignores alternatives that would save California tax and ratepayers billions of dollars, while investing in the jobs and local water sources that build sustainability.

## My environmental concerns with the plan are:

- The impact on wildlife and plant species in the Delta that depend on freshwater include the Delta smelt, chinook salmon, steelhead, San Joaquin kit fox, and tricolored blackbird, protected species already on the brink that will face decimation due to a diminishing food-web.
- · At sea, even the ESA-listed South Pacific Puget Sound Orca Whales depend on migrating Delta species that will be harmed by less water flowing through the Delta.
- The tunnels plan seems to ignore Section 7 of the Endangered Species Act which prohibits federal agency actions that are likely to jeopardize the continued existence of any endangered species or that "result in the destruction or adverse modification of [critical] habitat of [listed] species."

My public health concerns with the plan are:

- · The tunnels will cause increased contamination of municipal water and wells for the millions of rural and urban residents living in the five Delta counties.
- · The tunnels plan fails to model for potential increases of carcinogens and other formation of byproducts that would cause cancer and other serious health effects.

· Environmental justice communities, who depend on subsistence fishing, will also face food and health insecurities as a result of increased contaminants, specifically mercury contamination, in fish and wildlife populations.

## My economic concerns with the plan are:

- · For large metropolitan cities such as Los Angeles and San Jose that depend on export water, water rates and/or property taxes will go up, but they will get no additional water.
- · No analysis has been done on how the lack of fresh water flows will impact San Francisco Bay tourism and recreation. These industries depend on Delta fresh water flows for their crab and salmon fisheries, wildlife sighting, boating, and their restaurant economy. This industry is worth billions annually.
- · Salinity intrusion is already impacting the western Delta farms and removing Sacramento River freshwater from the system will make matters worse. Delta farmers cannot irrigate crops with salt water and they certainly cannot plant crops in contaminated soils. The Delta Ag economy, which consists of generations of family farms and farm workers, generates \$5.2 billion for the California economy, annually.
- · California coastal fishing communities depend on thriving wildlife. This historic industry is worth billions annually, with the salmon industry worth \$1.5 billion annually alone. Thousands of jobs and livelihoods are tied to these industries.
- The operation and construction of the tunnels will obstruct and disable navigable waterways for boating, marinas and other types of leisure activities, in addition to creating conditions of low water flow that will foster invasive aquatic species, such as water hyacinth. Poor water quality also creates unsafe recreation. Recreation and tourism in the Delta generate \$750 million annually.

# Alternatives to Water Exports Ignored

Far far less expensive and less environmentally destructive alternatives to the Delta Tunnels were largely ignored. The plan does not seriously consider any alternatives other than new, upstream conveyance. The decision-making process (from the outset) has tilted in favor of increasing water exports from the Delta.

Our tax and ratepayer dollars would be much better spent on:

- · More aggressive water efficiency program statewide that would apply to both urban and agricultural users.
- · Funding water recycling and groundwater recharging projects statewide that would be billions of dollars less expensive for rate payers than constructing a new version of the Peripheral Canal or major new surface storage dams. Meanwhile, these projects move communities towards water sustainability.
- · Retiring thousands of acres of impaired and pollution generating farmlands in the southern San Joaquin Valley and using those lands for more sustainable and profitable uses, such as solar energy generation.
- · Improving Delta levees in order to address potential earthquake, flooding, and future sea level rise concerns at a cost between \$2 to \$4 billion and is orders of-magnitude less expensive than major conveyance projects that are currently being contemplated.
- · Increasing freshwater flows through the Delta to reduce pollutants so ecosystems and wildlife can be restored.
- · Installing fish screens at the south Delta pumps to reduce the current salvage of marine life.

## In Summary

The Delta has problems that need to be addressed, but the CA Water Fix tunnels are a 20th century idea that won't fix them. It won't produce more water, more reliable supplies, or improved conditions for the environment in the Delta.

The new EIR/EIS has not adequately addressed my above stated concerns. That is why I oppose the Delta Tunnels/California Water Fix (Alternative 4A).

Reclamation and DWR should prepare and circulate a new Draft EIR/EIS that will include alternatives that reduce water exports and increase Delta flows for consideration by the public and decision-makers. Such alternatives have a far better chance of complying with the Delta Reform Act and the federal Endangered Species and Clean Water Acts.
