Dear Hearing Officers:

This correspondence is submitted on behalf of South Delta Water Agency, Central Delta Water Agency, Lafayette Ranch, Heritage Lands, Mark Bachetti Farms, and Rudy Mussi Investments L.P. ("Protestants.") These six Protestants constitute a group for purposes of efficient cross examination. Therefore, Protestants do not propose any further groupings at this time. As for the order of cross examination, Protestants' cross examination should not commence until after those interests representing export contractors, south of Delta users, and north of Delta water users have completed their respective cross examinations. Protestants also recommend that the hearing team afford maximum flexibility with regard to the coordination and availability of witnesses and that the proposed groupings and order of cross examination be distributed for comment before being finalized.


