15 Protestants County of San Joaquin, San Joaquin County Flood Control and Water Conservation

17 Protestants”), respectfully submit the following proposed groupings and order of Parties for cross-
18 examination in Part 1A. The undersigned has also consulted with attorney Jennifer L. Spaletta,
19 counsel for the North San Joaquin Water Conservation District, with respect to the proposed
20 groupings and order of cross-examination.

21 **Proposed Grouping of Protestants for Cross Examination in Part 1A:**

22 On behalf of the San Joaquin County Protestants, we propose that our three constituent parties
23 (County of San Joaquin, San Joaquin County Flood Control and Water Conservation District, and
24 Mokelumne River Water and Power Authority), as well as North San Joaquin Water Conservation
25 District, be grouped together for cross-examination in Part 1A of this proceeding. Ms. Spaletta, as
26 counsel for North San Joaquin Water Conservation District, concurs in this proposal.

27 **Proposed Order of Cross-Examination:**

28 The San Joaquin County Protestants request that our group, as described above, cross-examine

1 Petitioners' witnesses subsequent to cross-examination by the Central Delta Water Agency and South
2 Delta Water Agency. We also agree with the suggestion made by other Protestants that Hearing staff
3 provide a proposed order of groups for cross-examination and allow a short time for comments on that
4 proposal before finalizing the ordering of groups.
