Our protest is based on the adverse environmental impact the proposed changes will have on Clifton Court, L.P.

Clifton Court, L.P. owns the remaining 635 acres of Clifton Court, a once vibrant 3,000+ acres of farmland. Most of our farm was patented in the 1870's. We hold riparian and pre-1914 water rights as well as a Water License. When we first bought the farm in 1962, pre Clifton Court Forebay, we got our water through flood gates. Our historic Victorian home was barged into place in 1889.

It appears that the California WaterFix project now would like to take most of our property and leave a strip perhaps 80 feet wide between the banks of Old River and the banks of the Clifton Court Forebay. High Voltage lines would run between our land and the Forebay. The High Voltage lines are necessary for running the various pumps that are a part of this project.

Although our historic home and farmyard would be left in tact, the aesthetics of the 1870's farm would be changed. Our small strip of land would look like a bowling alley. Furthermore the property would be unusable due to the environmental problems caused by the High Voltage lines which would border our slim piece of land. It appears our farmland and water rights would be reduced to a few acres. We would maintain the levees and keep out trespassing fishermen who vandalize our pumps, equipment, and control panels. In short we would be left to deal with the ongoing damages caused by the attractive nuisance run by SWP & CVP.

To the best of our information and belief the proposed change or transfer will result in injury as follows:

The proposed changes in points of diversion and points of rediversion will injure Clifton Court, L.P. in many ways. First, most of our land and ancient water rights will be taken to accommodate the revised water plan. The remaining small strip of land will be bordered by High Voltage lines. Our farm will be virtually unusable yet we will be saddled with all the costs and problems it currently has.

As to possible injury, we can only look back at the farms history with CVP & SWP. In the 1950's and 1960's we couldn't imagine the ongoing damage that we are forced to deal with daily.

First of all we could never imagine that the CVP & SWP would pump a total of 15,000 cfs. causing well over \$1,000,000 worth of damage to our levees. The force of the pumping reverses the river and wrecks our levees and water quality, yet none of these injuries were predicted.

Next our farm historically got its water from flood gates and gravity flow. As we gradually had to transfer to all pumps, we never dreamt the price of electricity would rise so drastically. We never dreamt that our pumps would cavitate and use huge amounts of power when the water level in the Delta Mendota Canal would drop 10 feet due to trash on the racks. We never dreamt we would have to replace pumps that burnt out when water level unnaturally plummeted.

Then, we never dreamt that trespassing "fishermen" would vandalize and wreck our pumps. To begin with both the CVP and SWP had excellent 24 hour patrols. We had no problems with trespassers. The property and fence around Clifton Court Forebay were well maintained. Rodents were controlled. That stopped in the 1970's. We've spent hundreds of thousands of dollars correcting the problems caused by CVP and SWP not properly maintaining their facilities, basically allowing an attractive nuisance to fester.

Since our family bought the farm in 1961, we have dealt with many directors of Clifton Court Forebay, California Valley Project, State Water Project, and Department of Water Resources. We are constantly assured that things will be different now that "I" am in charge. So far we have not received a dime in damages. No one has offered to fix and maintain our levee or pay for ruined pumps. We would like our past injuries to be paid for before we guess what our next injuries will be. We would like an EIR/EIS to be performed on the existing SWP and CVP so that we can accurately fix the broken system.
