# Adoption of Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary

NOTICE IS HEREBY GIVEN that a public meeting will be held by the State Water Resources Control Board (SWRCB) to consider adoption of the Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (Plan).

#### BACKGROUND

In 1994, the SWRCB began proceedings to review the 1991 Water Quality Control Plan for Salinity for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (Bay-Delta Estuary). A series of six SWRCB public workshops and three SWRCB staff workshop sessions were held from April through October 1994 to seek comments and recommendations regarding standards for the Bay-Delta Estuary. The SWRCB released a draft Plan on December 15, 1994 and subsequently released a draft Environmental Report, which documents the SWRCB's analysis of the needs for and the effects of implementing the draft Plan, for public review. A public hearing was held on February 23, 1995 to receive comments on the draft Plan and Environmental Report.

After consideration of all comments received the SWRCB revised the draft Plan. This revised draft Plan is available as of the date of this notice. Two additional documents, the Response to Comments, which provides written responses to public comments received in conjunction with the February 23, 1995 public hearing, and the revised draft Environmental Report will be available for public review beginning at 8:00 a.m. on May 12, 1995. Instructions for requesting copies of the revised draft Plan, Environmental Report, and Response to Comments are provided in the attachment.

DIS-CUSSION:

In April 1994, the SWRCB began proceedings to review the 1991 Water Quality Control Plan for Salinity for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary. A series of six SWRCB public workshops and three SWRCB staff workshop sessions were held from April through October 1994 to seek comments and recommendations regarding standards for the Bay-Delta The SWRCB released a draft Bay-Delta Plan on Estuary. December 15, 1994 and subsequently released a draft Environmental Report, which evaluated the effects of implementation of the draft Bay-Delta Plan, for public review. A public hearing was held on February 23, 1995 to receive comments on the draft Bay-Delta Plan and Environmental Report. After consideration of all comments received, the SWRCB revised the draft Plan. Written responses to public comments received in conjunction with the February 23, 1995 public hearing are provided in the Response to Comments document.

The draft Bay-Delta Plan, once adopted, will replace the 1978 Delta Plan and the 1991 Bay-Delta Plan. Implementation of the Bay-Delta Plan will occur through a combination of water quality and water right actions, and through measures taken by other agencies.

POLICY Should the SWRCB adopt the draft Bay-Delta Plan? (The ISSUE: draft Bay-Delta Plan includes the appended draft Environmental Report and the Response to Comments.)

FISCAL Implementation measures taken by the SWRCB and Regional IMPACT: Boards as a result of adoption of the Bay-Delta Plan will be completed within budgeted resources.

REGIONAL Yes. San Francisco Bay Regional Board (Region 2) and BOARD Central Valley Regional Water Quality Control Board IMPACT: (Region 5).
