WITHDRAWAL OF ADMINISTRATIVE CIVIL LIABILITY COMPLAINT FOR FAILURE TO FULFILL OBLIGATIONS UNDER STATE WATER RESOURCES CONTROL BOARD ORDER WR 2015-0026-DWR

On December 15, 2015, the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), issued an Administrative Civil Liability (ACL) Complaint to CHRISTINE C HILL for failure to fulfill obligations under State Water Board Order WR 2015-0026-DWR<sup>1</sup>.

Landowner records were based on the best available information, as provided by the Sonoma County Clerk-Recorder-Assessor's Office. Since no communication was received prior to December 15, 2015, the Division believed CHRISTINE C HILL to be the owner of parcel number(s) 078-140-001-000.

In response to the December 15, 2015 ACL Complaint, you informed the Division that the property was sold prior to when Order WR 2015-0026-DWR took effect. Division staff reviewed the information provided and has determined that the property was sold prior to when Order WR 2015-0026-DWR took effect. Based on review of the additional information, the Division withdraws the ACL Complaint.
