### DIVERSION OF WATER UNDER LICENSE 5496 (APPLICATION 14516), LITTLEJOHNS CREEK IN SAN JOAQUIN COUNTY

The State Water Resources Control Board (State Water Board), Division of Water Rights (Division) is in receipt of CT Corp System's (CT) letter dated October 24, 2012. CT's letter was a response to the State Water Board's draft Cease and Desist Order (CDO) concerning primary owner Simpson Mfg Company Inc.'s (Simpson) failure to report annual water use for the year 2011 under water right License 5496. CT's letter informed the State Water Board that CT was unable to forward the draft CDO to the addressed party.

Upon further investigation of License 5496, it appears that water has not been diverted or put to beneficial use since the year 1994 (most recent reported year of use). In addition, the authorized place of use, originally irrigated as row crops, has been converted to industrial buildings. Therefore, it appears to the Division that this water right has been abandoned, yet CT, who is the water right agent on file, is continuing to pay the annual license fee of \$316.83 each year.

Enclosed with this letter is a *Revocation Request* form, which, given the lack of reported use for the past 19 years and elimination of the authorized place of use, should be considered to avoid annual fees on a right that has likely been abandoned. By revoking the license, CT, acting as agent for primary owner Simpson Mfg Company Inc. et al., will be relieved of all responsibilities associated with License 5496, including the annual license fee. You may fill out and complete the form and submit it to the Division in a stamped envelope.

Once the Division receives your signed revocation form, the Division will notify all the co-owners of the water right (see attached list) of the request for revocation and allow 30 days to object. If no objections are received, the Division will proceed with the revocation of License 5496. Please submit the signed revocation form to:

It is my responsibility to consult with the Department of Fish and Game, the Regional Water Quality Control Board and, if a jurisdictional size dam will be removed or breached, the Department of Water Resources, Division of Safety of Dams to ensure that removal of project facilities does not adversely affect a fishery or result in unregulated sediment discharge to a waterway. These agencies may require a permit prior to any construction activity.
