WITHDRAWAL OF DRAFT CEASE AND DESIST ORDER FOR FAILURE TO FILE 2010 ANNUAL USE REPORT UNDER LICENSE 6175 (APPLICATION 15236) SKUNK CREEK IN SACRAMENTO COUNTY

On May 23, 2012, the State Water Resources Control Board (State Water Board), Division of Water Rights (Division) provided legal notice to the City of Galt (City) of the intent to proceed with formal enforcement for failure to file the City's 2010 annual use under the subject water right. You had 20 days from receipt of the draft Cease and Desist Order (CDO) to submit your 2010 annual use records through our online reporting system or face imposition of a \$1,000 per day liability.

Upon a further review of the Division's records, we find that the City did not obtain ownership of the subject water right until February 8, 2011. As a result, the City would not likely have any 2010 water usage to report or any knowledge of past diversions by the prior owner.

As a result of this new information, the Division hereby withdraws the draft CDO issued on May 23, 2012 and will take no further action regarding the CDO. Please note that the City must report their 2011 usage under the subject right by July 1, 2012 or be subject to a similar enforcement action.


