CEASE AND DESIST ORDER FOR FAILURE TO FILE PROGRESS REPORT BY PERMITTEE UNDER PERMIT 20576 (APPLICATION A029809), DIVERSION OF WATER FROM UNNAMED STREAM IN SOLANO COUNTY

Enclosed is a Cease and Desist Order (CDO) for failing to report your 2010 Progress Report by Permittee (Report) under the above-referenced right. This letter serves as notice of the intent of the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), to adopt the CDO. Therefore, this matter requires your immediate attention.

In February 2011, the Division mailed out an initial notification letter to all permittees, including you, advising of the new requirement to submit your Report online. The letter gave the website address of our new reporting system as well as the access information specific to each permittee. The deadline to submit your 2010 Report was July 1, 2011.

In September 2011, the Division mailed out delinquency letters to a portion of permittees, of which you were a part, indicating that your 2010 Report had not been received. The delinquency letter stated the penalties for non-submittal as well as providing Division contact information for assistance. As a courtesy, the delinquency letter included a copy of our February 2011 notification letter.

As of the date of this letter, the Division has not received your 2010 Report for the subject right. Therefore, you are in violation of the terms or conditions of your permit.

Within 20 days from the date you receive this notice, you must: (1) Come into compliance with the terms of your permit by submitting your 2010 Progress Report by Permittee; or (2) submit a written request for a hearing on the draft CDO, as described below.

If you disagree with the facts or time schedules for the corrective actions set forth in the CDO, you may request a hearing before the State Water Board. **Your request for a hearing must be in writing, signed by you or on your behalf, and mailed or hand-delivered to ensure receipt by the State Water Board within 20 days from the date you receive this notice.**

You may mail your written hearing request to: State Water Resources Control Board, Division of Water Rights, Attn: Enforcement Section, P.O. Box 2000, Sacramento, CA 95812-2000.

You may hand-deliver your written hearing request to: State Water Resources Control Board, Division of Water Rights, Records Unit, 1001 I Street, 2nd Floor, Sacramento, CA 95814.

If you request a hearing, a hearing will be scheduled before the State Water Board or a designated hearing officer. Prior to the hearing, you will be required to submit any written testimony and other evidence you would like the State Water Board to consider. You will be notified of the hearing date and the submittal deadlines as soon as they are scheduled.

If you fail to come into compliance or request a hearing within 20 days of the date you receive this notice, the State Water Board will adopt the CDO. If you fail to comply with the adopted CDO, the State Water Board may consider additional enforcement of the CDO without further notice. Such enforcement may include the imposition of administrative civil liability of up to \$1,000 for each day of noncompliance, or referral to the Attorney General for further action.

The State Water Resources Control Board (State Water Board or Board) is authorized under Water Code section 1831 to issue a Cease and Desist Order (CDO) requiring Joseph E Awender (referred to herein as Permittee) to cease and/or abate a threatened or ongoing violation of the terms and conditions of your permit.

Permittee is alleged to have violated or is threatening to violate California Water Code section 1052 for which section 1831 (d) provides, in part:

The State Water Board is authorized to issue a Cease and Desist Order when it determines that any person is violating or threatening to violate any of the following:

(2) Any term or condition of a permit, license, certification, or registration issued under this division.

On {DATE}, and in accordance with the provisions of section 1834 of the California Water Code, the State Water Board, Division of Water Rights (Division) provided notice of the CDO against Permittee for the violation of the terms and conditions of your permit and/or Title 23, Division 1, Chapter 2, Article 20, section 847 of the California Code of Regulations. Pursuant to State Water Board Resolution 2007-0057, the Deputy Director for Water Rights is authorized to issue a notice of cease and desist, and when a hearing has not been timely requested, issue a CDO in accordance with Water Code section 1831 et seq. State Water Board Resolution 2007-0057 also authorizes redelegation of this authority from the Deputy Director for Water Rights to the Assistant Deputy Director for Water Rights. This authority has been redelegated.

FACTUAL BASIS FOR ISSUING THE CDO

The facts and information upon which this CDO is based are as follows:

1. Senate Bill X7-8, which was signed into law in 2009, authorized the State Water Board to adopt regulations requiring online reporting of water diversions. Consistent with the Senate Bill, the State Water Board has adopted regulations requiring online reporting of water diversion and use under permits, and developed a new online Report Management System (RMS) as a component of the enhanced Water Right Information Management System (eWRIMS). The regulation specifying annual permittee reporting requirements is codified at Title 23, Chapter 2.7, Article 2, section 925 of the California Code of Regulations.

2. In February 2011, the Division mailed out an initial notice (Exhibit A) to the Permittee notifying them of: the recent online reporting change, instructions on how to access the RMS system and submit, at a minimum, their 2010 use report online. The Permittee was also notified that if they had any questions on the new reporting process, they could contact the Division by phone or email. The deadline to submit their 2010 use report online was July 1, 2011.
3. In September 2011, the Division mailed out delinquency letters, which also included a copy of the February 2011 letter, to all the permittees who had not submitted their 2010 use report by July 1, 2011 (Exhibit B). The delinquency letter provided notice that failure to submit the annual use report was a violation of the terms and conditions of the applicable permit and/or Chapter 2, Article 20, section 847 of the California Code of Regulations, and that continued failure to submit the annual use report may result in enforcement action by the State Water Board.
4. As of May 23, 2012, the Division has not received the permittee's 2010 annual use report.

IT IS HEREBY ORDERED, pursuant to sections 1831 through 1836 of the California Water Code, that:

1. Permittee shall immediately come into compliance with the terms of the Permit by submitting their report of 2010 annual use by accessing the Report Management System at www.waterboards.ca.gov/RMS using the User ID and Password shown on User Information Sheet accompanying this CDO.

Please note the User ID is a seven-digit alphanumeric string that begins with the letter "A" and followed by six numbers corresponding to your original application number. If you have any problems accessing the reporting system, please contact the Division staff noted on the letter accompanying this CDO.

Consequences of Non-Compliance

In the event Permittee fails to comply with the requirements of this Order, Permittee shall be in violation of this CDO and subject to additional enforcement, which may include the imposition of administrative civil liability pursuant to Water Code section 1845 (b)(1) of up to \$1,000 for each day in which the violation occurs, or referral to the Attorney General to take further enforcement action as described in California Water Code section 1845(a):

Upon the failure of any person to comply with a cease and desist order issued by the board pursuant to this chapter, the Attorney General, upon the request of the board, shall petition the superior court for the issuance of prohibitory or mandatory injunctive relief as appropriate, including a temporary restraining order, preliminary injunction, or permanent injunction.

Reservation of Enforcement Authority and Discretion

Nothing in this Order is intended to or shall be construed to limit or preclude the State Water Board from exercising its authority under any statute, regulation, ordinance, or other law, including but not limited to, the authority to bring enforcement against Permittee for unauthorized diversion of water in accordance with Water Code section 1052.

Regulatory Changes

Nothing in this Order shall excuse Permittee from meeting any more stringent requirements that may be imposed hereafter by applicable legally binding legislation, regulations or water right permit requirements.
