Dear Mrs. Jensen,

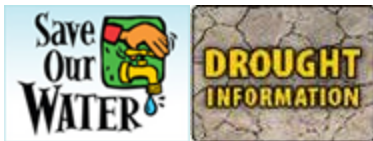
