### **SUBJECT OF HEARING**

The State Water Resources Control Board (SWRCB) may reconvene the water right hearing on the Delta Wetlands (DW) Project to receive evidence on whether to accept in evidence the Final Environmental Impact Report (FEIR) for the DW Project.

#### **BACKGROUND**

In accordance with a Notice of Resumption of Public Hearing dated June 16, 2000, the SWRCB held a hearing to receive evidence regarding the water right applications for the DW Project. A copy of the hearing notice may be obtained from Jim Sutton, whose phone number is listed below. The SWRCB completed an FEIR for the DW Project after October 12, 2000, the date of the completion of the water right hearing. The SWRCB issued a Draft EIR/Environmental Impact Statement (EIS) on September 11, 1995 and a Revised Draft EIR/EIS on May 31, 2000. The SWRCB received both documents into evidence.

By letter dated January 12, 2001, the SWRCB informed the parties to the DW Project Water Right Hearing that it intends to accept the FEIR in evidence as SWRCB Exhibit 2b, unless it receives objections requiring a hearing by January 24, 2001. The SWRCB will convene this hearing only if a party or parties file objections that require an evidentiary hearing.

#### **HEARING ISSUE**

# Should the SWRCB accept in evidence the FEIR for the Delta Wetlands Project?

Parties will be allowed to address whether the FEIR should be accepted into evidence at the hearing. Only the admissibility, and not the adequacy of the FEIR under the California Environmental Quality Act, is an issue at this hearing. The SWRCB will consider whether to certify the FEIR at a SWRCB meeting to be held on February 15, 2001.

The SWRCB will make available for testimony Ms. Aimee Dour-Smith, DW Project Manager for Jones and Stokes Associates, Inc., the SWRCB's consultant for the preparation of the FEIR. Ms. Dour-Smith will testify regarding the FEIR, and will then be available for cross-examination by the parties. Cross-examination will be limited to information in the FEIR. No new significant impacts are identified in the FEIR.

Parties may present evidence, cross-examine witnesses, and present rebuttal consistent with the Notice of Resumption of Hearing dated June 16, 2000, identifying specific issues and reasons supporting objections to the admission of the FEIR into the administrative record.

# **HEARING PARTICIPATION**

This hearing is being conducted in accordance with the Notice of Resumption of Public Hearing dated June 16, 2000. The procedural requirements specified in that notice apply, except as modified herein. Any party objecting to the admission of the FEIR in evidence shall provide written objection to the SWRCB. Such written objection shall include specific information detailing the reasons for the objection. Any party filing an objection shall file a Notice of Intent to Appear (NOI), a Supplemental List of Exhibits (List) and its exhibits by the deadline. The NOI, List, and ten copies of any exhibits must be received by the SWRCB no later than 4:00 PM on Wednesday, January 24, 2001. Please mail these items to the following address:
