By letter dated <u>August 24, 2016</u>, I granted the joint request by the California Department of Fish and Wildlife (CDFW) and El Sur Ranch (ESR) to hold any further actions regarding water right Application 30166 in abeyance until December 31, 2016, and set preliminary hearing dates of February 28 through March 3, 2017.

On December 27, and December 29, 2016, CDFW and ESR, respectively, informed the Board that 1) CDFW anticipates transmitting the final flow recommendations in early 2017, and 2) CDFW and ESR actively continue to seek settlement. In light of this information, the preliminary hearing dates described above are cancelled.

The letters do not include a request for a specific period of continued abeyance or a date by which the parties expect settlement negotiations to have concluded. For a request for an extension of the abeyance period to be considered, CDFW and ESR are directed to submit no later than **noon**, **February 16**, **2017**, an estimated time schedule for conclusion of the negotiations.
