The State Water Resources Control Board scheduled a Public Hearing to Determine Whether to Adopt a **Cease and Desist Order** and Impose an **Administrative Civil Liability Complaint** Against Garrapata Water Company, Inc.

#### SUBJECT OF THE CANCELLED HEARING

The State Water Resources Control Board (State Water Board) scheduled a hearing to receive evidence relevant to determining whether to adopt, with or without revision, a draft Cease and Desist Order (CDO) and an Administrative Civil Liability Complaint (ACL Complaint) issued on June 10, 2008 against Garrapata Water Company, Inc. (GWC).

By Notice of Postponement of Public Hearing, dated January 29, 2010, the State Water Board postponed the February 22<sup>nd</sup> hearing at the request of GWC and the Division of Water Rights Prosecution Team. On September 9, 2010, the State Water Board's Executive Director issued Water Right Order <u>WR 2010-0028-EXEC</u> (Order Approving Settlement Agreement and Cease and Desist Order). Accordingly, no hearing is required to be held concerning the proposed CDO and ACL Complaint and the previously postponed hearing is cancelled.
