## NOTICE OF CANCELLATION OF PUBLIC HEARING

The State Water Resources Control Board (State Water Board) has cancelled the Public Water Right Hearing to Consider a Petition by Yuba County Water Agency to Change the Effective Date of the Long-Term Instream Flow Requirements Established in Revised Decision 1644 Involving Water Right Permits 15026, 15027 and 15030 (Applications 5632, 15204 and 15574) of Yuba County Water Agency Affecting the Lower Yuba River in Yuba County

## SUBJECT OF THE CANCELLED HEARING

On August 23, 2006, Yuba County Water Agency (YCWA) filed a petition to change the effective date of the long-term instream flow requirements specified in State Water Board Revised Decision 1644 (RD-1644) from March 1, 2007 to April 1, 2008. The purpose of this hearing was for the State Water Board to receive evidence relevant to determining whether to defer the effective date of the long-term flow requirements established in RD-1644 and Order WR 2006-0009, as requested in the petition. The hearing would have provided an opportunity for the petitioner, interested parties, and any protestants to the petition to introduce evidence relevant to the State Water Board's consideration of the petition.

On November 20, 2006, YCWA filed a request to cancel the December 11-12, 2006 hearing because no party protested YCWA's petition, and because no party filed a Notice of Intent to Appear at the hearing in opposition to YCWA's petition. In the absence of protests or a disputed issue of material fact, no hearing is required to be held on the petition and the previously scheduled hearing is cancelled.
