#### SUBJECT OF THE CANCELED HEARING

The purpose of this hearing was for the State Water Resources Control Board (State Water Board) to receive evidence relevant to determining whether to adopt, with or without revision, two enforcement measures proposed for issuance on July 10, 2008, relating to the alleged unauthorized diversion of water: draft Cease and Desist Order 2008-00XX-DWR (CDO) and an Administrative Civil Liability (ACL) Complaint (Complaint) issued against Manchester Ridge LLC (Manchester) and against Harriet Jean Piper, William Piper, Matthew Piper, Carole Canaveri, and Kathleen Stornetta (Piper et al.). By letter dated July 24, 2008, Manchester requested a hearing on the ACL Complaint and draft CDO.

By Notice of Postponement of Public Hearing, dated April 15, 2009, the State Water Board postponed the April 20, 2009 hearing upon receipt of requests for postponement by Manchester and the Division of Water Rights Prosecution Team (Prosecution Team). On May 1, 2009, the

State Water Board's Executive Director approved a Settlement Agreement between the Prosecution Team and Manchester Ridge, LLC (<u>ORDER WR 2009-0030-EXEC</u>). Accordingly, no hearing is required to be held on the draft cease and desist order or ACL complaint and the previously postponed hearing is cancelled.
