The State Water Resources Control Board will hold a pre-hearing conference on Applications 18334X02, 30521, 30522, and 30552 of Pajaro Valley Water Management Agency to appropriate water from College Lake (Salsipuedes Creek), Harkins and Watsonville Sloughs, and Pajaro River (Murphy's Crossing) in Santa Cruz County.

SUBJECT OF PRE-HEARING CONFERENCE

On April 18, 2003, The State Water Resources Control Board (SWRCB) issued a Notice of Public Hearing and Pre-Hearing Conference. The notice specified that the purpose of the pre-hearing conference was to discuss the scope of the hearing, the status of protests, and any other appropriate procedural issues.

This Amended Notice of Pre-Hearing Conference provides additional notification that the SWRCB requests that the parties be prepared to address the issue of the appropriateness and acceptability of including the protest dismissal conditions in the November 3, 1999, agreement between Pajaro Valley Water Management Agency and the California Coastal Commission in any water right permit that may be issued pursuant to one or more of the pending applications. The parties should also be prepared to discuss the status of the protest of the Department of Fish and Game.

All parties who have previously filed notices of intent to appear in the hearing are required to attend the June 2, 2003 Pre-Hearing Conference.

PARKING, ACCESSIBILITY, AND SECURITY

The enclosed maps show the location of the Joe Serna Jr./Cal EPA Building and public parking sites in Sacramento. The Joe Serna Jr./Cal EPA Building Sierra Room is accessible to persons with disabilities.

Due to enhanced security precautions at the Cal/EPA Headquarters Building located at 1001 I Street, Sacramento, all visitors are required to sign in prior to attending any meeting. Sign-in and badge issuance occur in the Visitor and Environmental Services Center. This Center is located just inside and to the left of the building's public entrance. Depending on their destination and the building security level, visitors may be asked to show valid picture identification. Valid picture identification can take the form of a current drivers license, military identification card, or state or federal identification cards. Depending on the size and number of meetings scheduled on any given day, the security check-in could take from three to fifteen minutes. Please allow adequate time to sign in before being directed to your meeting.

Ex parte communications with members of the Board or SWRCB staff on the hearing team regarding substantive or controversial procedural matters involved in the hearing are prohibited during the pendency of this proceeding. 




