## SUBJECT OF WORKSHOP

The State Water Resources Control Board (State Water Board) will accept comments regarding a draft Cease and Desist Order (CDO) against Woods Irrigation Company (Woods). A quorum of the State Water Board members may be present. After receiving the comments, the members may provide direction to staff regarding changes to the draft. The draft order can be viewed at:

### BACKGROUND

On December 28, 2009, the State Water Board's Assistant Deputy Director for Water Rights issued a notice of proposed CDO to Woods for the alleged violation and threatened violation of the prohibition against the unauthorized diversion or use of water. On January 11, 2010, Woods requested a hearing. The State Water Board held a five-day evidentiary hearing on June 7, 24, 25, 28, 2010, and July 2, 2010.

The proceedings were held in Sacramento, California in order to receive evidence relevant to determining whether to adopt, with or without revision, the proposed CDO against Woods. The State Water Board released the draft CDO on December 15, 2010.

#### **PROCEDURAL MATTERS**

At the workshop there will be no sworn testimony or cross-examination of participants, but the State Water Board and its staff may ask clarifying questions. Participants should submit written comments prior to the workshop. At the workshop, participants will be given an opportunity to summarize and supplement their written materials with oral presentations.

To ensure a productive and efficient workshop, and to ensure that all participants have an opportunity to participate, oral presentations from any interested persons will be limited to <u>3 minutes</u> or otherwise at the discretion of the Board Chairman. Participants with similar comments are requested to make joint presentations.

Interested persons and parties are encouraged to submit their comments in writing. In order to be fully considered, written comments concerning the draft order must be received by 12:00 noon on January 11, 2011, in order to be considered by the State Water Board prior to the workshop.
