### NOTICE OF OPPORTUNITY TO COMMENT

#### PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SACRAMENTO AND SAN JOAQUIN RIVER BASINS TO ESTABLISH A DRINKING WATER POLICY FOR SURFACE WATERS OF THE DELTA AND ITS UPSTREAM TRIBUTARIES

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Central Valley Regional Water Quality Control Board's (Central Valley Water Board's) amendment to the Water Quality Control Plan for the Sacramento and San Joaquin River Basins that would establish a Drinking Water Policy for surface waters of the Delta and its upstream tributaries (Basin Plan amendment). The Basin Plan amendment was adopted by the Central Valley Water Board on July 26, 2013 (R5-2013-0098), and is available for review at:

**REQUEST NOTICE OF STATE BOARD MEETINGS.** The State Water Board will separately publish an agenda for the meeting at which it will consider adopting a resolution approving the Basin Plan amendment. Oral comments at the State Water Board meeting generally will be limited to a summary of the written comments submitted during the written comment period. **SUBMISSION OF WRITTEN COMMENTS.** Persons interested in the Basin Plan amendment are encouraged to submit comments electronically. Comment letters **must be received by 12:00 noon on November 8, 2013**. Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise.

**REQUIREMENTS FOR SUBMITTING COMMENTS** (23 Cal. Code Regs., § 3779, subd. (f)).  
The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

1. Comments must specifically address the final version of the Basin Plan amendment adopted by the Central Valley Water Board.
2. If the Central Valley Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Central Valley Water Board to each comment was inadequate or incorrect.
3. The commenter also must include either a statement that each of the comments was timely raised before the Central Valley Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Central Valley Water Board.
