On July 30, 2021, the State Water Resources Control Board (State Water Board) provided notice that the above-referenced petitions were consolidated for review and that the Central Coast Regional Water Quality Control Board (Central Coast Water Board) and other interested persons may file a written response to the petitions within 30 days. In addition, the State Water Board requested that the Central Coast Water Board file the administrative record within this 30-day period.

On August 4, 2021, the Central Coast Water Board requested (1) a 60-day extension of time, until October 28, 2021, to submit responses to the petitions, and (2) a 15-day extension of time, until September 13, 2021, to submit the administrative record.
