#### **TO ALL PARTIES:**

On July 12, 2022, the State Water Resources Control Board's Division of Water Rights (Division) issued to Respondent, John Long, an administrative civil liability complaint (ACL Complaint) and draft cease and desist order (Draft CDO), based on an inspection of the property identified as Trinity County APN 018-230-24-00. Respondent requested a hearing in this matter on August 4, 2022. The State Water Resources Control Board's Administrative Hearings Office (AHO) issued a Notice of Public Hearing on November 12, 2022. This Notice of Public Hearing set a hearing date of January 10, 2023 at 9:00 a.m.

On December 21, 2022, Andrew Tauriainen, an attorney with the Office of Enforcement, e-mailed the AHO an executed settlement agreement between the Division and the Respondent, and proposed order approving the settlement agreement.

Based on the Division's settlement agreement with Respondent, the AHO cancels the hearing in this matter that was scheduled for January 10, 2023, at 9:00 a.m.
