1 This cause having been referred to the Division of Water Resources
2 of the Department of Public Works of the State of California, as referee, by
3 order of this Court, dated May 13, 1931, made under authority of section 24
4 of the Water Commission Act of the State of California (Stats. 1913, page
5 1012, as amended); and, in accordance with law, the said referee having made
6 its investigation and submitted its report to the Court; and, it appearing
7 that a stipulation for judgment has been entered into and agreed upon by all
8 the parties to the above-entitled cause, except defendants Ernest E. Cook and
9 Alta Cook, his wife, George M. Hudspeth and Mary Hudspeth, his wife, E. E.
10 Murphey and Susan Murphey, his wife, Charlie Lee Pabst, E. B. Woodruff and
11 Charles Nolan as successor to J. J. Wiley; and it further appearing that
12 said stipulation for judgment, on file herein, provides, in part, that find-
13 ings of fact and conclusions of law are waived and that judgment and decree
14 in accordance with the terms of said stipulation and report of referee may be
15 entered; and, an order of this Court having been made fixing time for hearing
16 exceptions heretofore filed to report of referee on October 21, 1937, said
17 order having been duly served upon all the parties to this action; and said
18 cause having regularly come on for trial before the above-entitled Court,
19 sitting without a jury, on said 21st day of October 1937; the plaintiffs,
20 Arthur J. Harris and Etta M. Harris, his wife, appearing in propria persona;
21 C. S. Baldwin, appearing as attorney for defendants, E. E. Murphey and Susan
22 Murphey, his wife, and Charlie Lee Pabst; A. K. Wylie appearing as attorney
23 for defendant, Grace A. Street; the defendants, Fred Meyers and Elizabeth Meyers
24 his wife, E. B. Woodruff, Ernest E. Cook and Alta Cook, his wife, appearing in
25 propria persona; no appearances being made by or on behalf of any of the re-
26 maining defendants; all of the parties appearing, having stipulated in open
27 court that the Court might adopt the findings of fact and conclusions of law
28 contained in report of referee, with the exceptions set forth in order of the
29 Court, dated October 21, 1937, and that judgment and decree be entered in
30 accordance therewith; parties not appearing for said trial having thereby
31 waived findings of fact and conclusions of law; said cause having been

1 submitted and the evidence closed; said Court having approved and adopted
2 said findings of fact and conclusions of law by said order, dated October 21,
3 1937; and the Court, being fully advised, now enters its judgment and decree
4 in accordance therewith as follows:

5 I

6 NOW THEREFORE IT IS ORDERED, ADJUDGED AND DECREED, that there is
7 in said Madoc County a natural stream of water known as and called "Eagle
8 Creek," which said stream arises on the eastern slope of the Warner Range
9 of mountains in the southerly portion of said county, and flows thence in a
10 general easterly direction into Surprise Valley past the Town of Eagleville
11 and thence the channel divides into two branches known as and called "South
12 Channel" and "Old Channel", and said stream so flows between well defined
13 banks in well defined channels to, upon, and across certain of the lands of
14 certain of the parties to this action.

15 II

16 That as to the parties herein the following is found:
17 Defendant Fannie Barber has died since the commencement of this
18 action and defendant L. J. Barber, surviving husband, has succeeded to the
19 interests of said Fannie Barber.

20 Frankie C. Stevens has succeeded to the interests of Defendant
21 Jennie M. Cambron and the interests of said Frankie C. Stevens have been
22 included under the name of Jennie M. Cambron in the stipulation for judg-
23 ment on file in this action.

24 The interests of defendant sued herein as () Dorton, wife
25 of C. M. Dorton have been included under the name of C. M. Dorton in the
26 stipulation for judgment on file in this action.

27 Martha M. Cook has died since the commencement of this action and
28 her heirs are Floyd Cook and Kenneth Cook and defendants Ernest E. Cook and
29 Neva L. Kelly.

30 N. H. Finmand and Niels H. Finmand are one and the same person.

31 Defendant M. Hotchkiss has died since the commencement of this

1 action and defendant Alleva Hotchkiss, surviving wife, succeeded to his
2 interests and then said defendant Alleva Hotchkiss died and Bessie Ward has
3 succeeded to the interests of the Estate of Alleva Hotchkiss.

4 The true name of defendant sued herein as Sara E. Powers is Sabra
5 E. Powers, and she has appeared in said action under her true name.

6 Charles Nolan has succeeded to the interests of defendants J. J.
7 Wiley, G. F. Prior and Mariam T. Prior.

8 Mrs. S. J. Millsap was not served with summons and complaint and did
9 not originally make an appearance in said action; said Mrs. S. J. Millsap
10 has signed the stipulation for judgment on file in said action; and the
11 interests of said Mrs. S. J. Millsap have been included in the allotment
12 made to her in said stipulation for judgment.

13 Walter Harden, Melvin Harden, Cecial Harden, and Frank Harden are
14 interested with defendants J. T. Reeder and Katie Reeder in the property
15 and rights designated as belonging to J. T. Reeder and Katie Reeder, et al.

16 The true name of defendant sued herein as Margaret Stevens is
17 Marguerite Stevens, and she has appeared in said action under her true name.

18 The true name of defendant sued herein as Lolo Taylor is Lola Taylor,
19 and she has appeared in said action under her true name.

20 The true name of defendant sued herein as Pete Itcaina is Pete
21 Ytzaina, and he has appeared in said action under his true name; and Mary
22 Ytzaina is interested with said defendant Pete Ytzaina in the property and
23 rights designated as belonging to said Pete Ytzaina.

24 The true name of defendant sued herein as Neva Kelley is Neva L.
25 Kelly, and she has appeared in said action under her true name.

26 Jesse Stevens and Jesse W. Stevens are one and the same person.

27 Defendants J. Allen and () Allen his wife, and Clarence
28 Doss and Annie Doss have no interest in any water right from Eagle Creek and
29 have no interest in any of the lands involved in said action.

30 The true name of defendant sued herein as Mrs. Margaret Pickrett is
31 Margaret Pickrell; said Margaret Pickrell has died since the commencement of

1 this action; and Margaret Connolly is the heir of said Margaret Pickrell,
2 deceased.

3 Defendant Charlie Lee Pabst has succeeded to the interests of Lena
4 Harkey Scott.

5 III

V

The term "natural flow" as herein used, shall be construed to designate such flow as will naturally occur at any given point in a stream from the run-off of the watershed which it drains, from springs which naturally contribute to the stream, from seepage, and from waste and return flow from dams, conduits, regulatory storage, and irrigated lands; as distinguished from water released from seasonal storage and from "foreign water" directly conveyed to a stream from another watershed.

VI

The term "available water supply of Eagle Creek," as herein used, shall be construed to designate the total amount of water available for diversion by all of the various conduits diverting from said Eagle Creek, i.e., the water crop of said Eagle Creek plus all waste and return flows to the stream system, less all channel losses in the stream system; said "available water supply of Eagle Creek" at any given time to be determined by combining the total of all quantities of water being diverted from the stream system with the flows of Eagle Creek or its branches immediately below all diversions at the time.

VII

The "Division of Water Resources Map" herein referred to is the map prepared by the Division of Water Resources of the Department of Public Works of the State of California from its surveys made in 1931, which map is entitled, "Eagle Creek Showing Diversion System and Irrigated Land," and is dated 1931

VIII

All of the allotments of water hereinafter provided shall be

1 diverted from the Eagle Creek stream system at the present points of diver-
2 sion of the respective ditches, as said points of diversion are described in
3 Schedule 3, heroo; the points of measurement of all allotments of water
4 hereinafter provided shall be at the respective points of diversion from
5 said Eagle Creek and its branches; and the owners of allotments herein made
6 shall bear their respective delivery losses from said points of diversion to
7 their respective places of use, except that when the allotment of first
8 priority class of Ernest E. Cook and Alta Cook is being diverted by means of
9 the Gill Ditch, hereinafter described in Schedule 3, then at such times the
10 water available for allotments of first priority class in said ditch shall
11 be divided equally among the four users named under said ditch in Schedule
12 2 hereof.

13 IX

14 All allotments of water hereinafter provided shall be for continuous
15 usage without regard to season, except as otherwise provided by decree of the
16 above entitled court entered on April 5, 1926 in the case of Pabst v. Finmand,
17 and except as otherwise hereinafter provided in paragraphs 11, 13, 14, and 15;
18 provided however, that no party herein allotted water shall divert from said
19 Eagle Creek and its branches at any time, a quantity of water in excess of
20 that reasonably necessary for his requirements and being put to beneficial
21 use by said party.

22 X

23 Nothing in this judgment shall, or shall be construed to modify or
24 alter in any way the relative rights of defendants Grace A. Street, Charlie
25 Lee Pabst, Fred Meyers and Elizabeth Meyers, Charles Nolan and E.E.Murphey
26 and Susan Murphey with respect to each other as said rights have been deter-
27 mined by decree of the above entitled court entered on April 5, 1926 in the
28 case of Pabst vs. Finmand.

29 XI

30 Subject to the foregoing general provisions and definitions, the
31 several owners of rights in and to the use of the waters of Eagle Creek are

1 entitled to divert and use such waters as herein set forth.

2 XIII

3 Charlie Lee Pabst shall at all times be entitled to divert the entire
4 flow in the South Channel of Eagle Creek that occurs in said channel from
5 springs and return water below the head of said channel in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section
6 24, T.40N., R.16E., M.D.B. & M., (designated on Division of Water Resources
7 Map as Diversion 8); said water to be diverted from said channel, in whole or
8 in part, through any or all of the Pabst Diversions (designated on Division
9 of Water Resources Map as Diversions 18, 19, 20, 21, and 22) as described in
10 Schedule 3 hereunto annexed and made a part hereof; and said water to be used
11 for the irrigation of her lands described in Schedule 1 hereof.

12 XIII

13 The several parties named in Schedule 2 hereof shall be entitled to
14 rights in and to the use of the natural flow of Eagle Creek for domestic,
15 stock watering, and irrigation purposes upon their respective lands as de-
16 scribed in Schedule 1 hereof, in accordance with the priorities, the quanti-
17 ties of water allotted and through the ditches named as set forth in said
18 Schedule 2; provided, however, that the water to supply the allotment here-
19 inabove made to Charles Nolan shall first be taken from the drainage flow
20 from the Street Ranch in the Prior Collecting Ditch, and any deficiency below
21 said allotment, or the proration thereof, to said Charles Nolan in said drain-
22 age flow in said ditch shall then be made up by diversion from Eagle Creek;
23 provided further, that the water to supply the allotment hereinabove made to
24 Arthur J. Harris and Etta M. Harris shall first be taken from the drainage
25 flow in excess of 0.75 cubic foot per second from the Eyster Swamp in the
26 Eyster Slough Ditch, and any deficiency below said allotment or the proration
27 thereof, to said Arthur J. Harris and Etta M. Harris in said excess drainage
28 flow shall then be made up by diversion from Eagle Creek; and provided further
29 subject to the rights herein found for Grace Street and for the Scott Ranch
30 now owned by Charlie Lee Pabst to divert and use the waters of Eagle Creek by
31 means of the Gee and Grider Ditches, Ernest E. Murphey and Susan Murphey are

1 entitled to divert 0.30 cubic foot per second from said Eagle Creek by means
2 of said Grider Ditch for the irrigation of a garden upon the lands of said
3 Ernest E. Murphey and Susan Murphey as herein described; said garden right
4 of Ernest E. Murphey and Susan Murphey shall be superior to all rights
5 herein found for general irrigation in the third and fourth priority
6 classes; and said allotment to said Ernest E. Murphey and Susan Murphey
7 herein set forth for garden irrigation of 0.30 cubic foot per second is
8 not in addition to, but is a part of their total water requirements herein
9 found of 2.10 cubic feet per second.

10 XIV

11 At all times when the water supply of Eagle Creek, which is avail-
12 able for proration among all allotments within the third priority class
13 provided in Schedule 2 hereof, in excess of all prior rights, is equal to or
14 less than 4.50 cubic feet per second measured at the head of the Grider Ditch,
15 then the water under the allotment of Grace A. Street within the second
16 priority class in said Schedule 2 shall be pooled with said water available
17 for said allotments within the third priority class, and said Grace A. Street
18 shall be entitled during such times to divert one-half of such aggregate or
19 pooled water and Charlie Lee Pabst shall be entitled to divert the remaining
20 one-half of such aggregate; provided, however, that nothing in this paragraph
21 shall, or shall be construed to, limit the right of Grace A. Street to a
22 diversion of less than 5.00 cubic feet per second from said Eagle Creek at
23 any time prior to July 1st of each and every year when Charles Nolan, Fred
24 Meyers and Elizabeth Meyers, E. E. Murphey and Susan Murphey, and Charlie
25 Lee Pabst are receiving water by direct diversion from said Eagle Creek.

26 XV

27 That E. B. Woodruff is the owner of the following described acre-
28 ages of land:

29 38.5 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$ Sec. 24, T. 40 N., R. 16 E.; M.D.E. & M.
30 37.8 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 13, T. 40 N., R. 16 E.; M.D.E. & M.

31 that said lands lie in the watershed of Highrock Creek and are not riparian

1 to Eagle Creek; that said lands are irrigated by said owner; that said lands
2 are depicted in green upon the Division of Water Resources Map Sheet entitled,
3 "Eagle Creek Showing Diversion System and Irrigated Land," dated 1931, and
4 filed in the above entitled cause; that said owner diverts and uses, and is
5 entitled to divert and use water from the natural flow of Eagle Creek to
6 supplement the natural flow available from Highrock Creek for said land for
7 irrigation purposes; that diversion from said Eagle Creek is made by means
8 of the Gee Ditch at a point (designated on Division of Water Resources Map
9 as Diversion 3) which bears approximately N. 77° 0' W., approximately 2180
10 feet distant from the southeast corner of Section 23, T. 40 N., R. 16 E.,
11 M.D.B. & M., and being within the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 23; that the total
12 amount of water which said E. B. Woodruff diverts and is entitled to divert
13 through said ditch for said purposes is such a quantity of water as will fur-
14 nish him, together with the natural flow available from Highrock Creek, a
15 total flow of one cubic foot per second measured at the southwest corner of
16 the NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 24, T. 40 N., R. 16 E., M.D.B. & M., provided, however,
17 that the maximum rate of diversion from said Eagle Creek through said Gee
18 Ditch shall at no time exceed one cubic foot per second measured at the head
19 of said Gee Ditch; and such diversion shall be otherwise subject to the pro-
20 visions hereinafter set forth in paragraph XIX; that the diversion of, and
21 right to divert said quantity of water through said Gee Ditch is made, and is
22 during such times as the quantity of water available for said lands from
23 Highrock Creek is less than one cubic foot per second and when at the same
24 time there is water available for rights of third priority class from Eagle
25 Creek; that said allotment to said E. B. Woodruff shall bear its proportionate
26 share of the conveyance loss in said Gee Ditch; and that the amount of water
27 which said party is herein found to divert, and to be entitled to divert, is
28 sufficient and adequate to properly supply the requirements of said owner for
29 use upon said acreages for said purposes, is all the water reasonably neces-
30 sary therefor, and is a right of third priority class; provided, however, that
31 the diversion of said allotment to said E.B. Woodruff into said Gee Ditch and

1 the delivery thereof to the place of use hereinbefore described shall be
2 under the exclusive control of the Division of Water Resources or its duly
3 authorized water master appointed to administer the provisions of the decree
4 to be entered in this section.

XVI

Notwithstanding provisions in this decree to the contrary, the owners of rights of first, second and third priority classes, as set forth in Schedule 2 hereunto annexed and made a part hereof, can and do divert and use water from Eagle Creek and apply said water to beneficial use during the first irrigation in the spring of each and every year at faster rates of diversion than those set forth in said Schedule 2 until such times as their respective irrigated lands have received 0.6 acre-foot per acre; that the owners of rights of fourth priority class, as herein set forth in this decree, shall not divert any water from said Eagle Creek until said owners of first, second and third priority classes have received on their respective irrigated lands a first irrigation during the spring of each year equivalent to 0.6 acre-foot per acre; and that after said owners of first, second and third priority classes have received said first irrigation of 0.6 acre-foot per acre on their respective irrigated lands, then their respective maximum rate of diversion shall be as set forth in said Schedule 2 and said owners of rights of fourth priority shall then be entitled to divert from such excess over and above the aggregate of all allotment of first, second and third priority classes as set forth in said Schedule 2.

XVII

During the period from April 15th to October 1st of each and every year, Katie Reeder, Walter Harden, Melvin Harden, Cecial Harden, and Frank Harden, collectively, L. M. Mabrier, Robert C. Young, Estate of Margaret Pickrell, and Guy O. Wimer shall be entitled to divert by means of the Gee Ditch, hereinafter described in Schedule 3, 0.20 cubic foot per second as an allotment of first priority class in addition to the allotments of first priority class set forth in Schedule 2 hereof, and said parties shall rotate

1 in the use of said allotment of 0.20 cubic foot per second upon their respec-
2 tive lands described under their respective names in Schedule 1 hereof in
3 the proportion as follows:

9 XVIII

10 During the period from April 15th to October 1st of each and every
11 year, W. N. Slinkard and Gertie Slinkard, collectively, Eulalio Miura and
12 Elmore Miura, collectively, John W. Hanks and Cora Hanks, collectively,
13 L. J. Barber, C. M. Dorton, and Mrs. S. J. Millsap shall be entitled to
14 divert by means of the Grider Ditch, hereinafter described in Schedule 2,
15 0.20 cubic foot per second as an allotment of first priority class in addi-
16 tion to the allotments of first priority class set forth in Schedule 2
17 hereof, and said parties shall rotate in the use of said allotment of 0.20
18 cubic foot per second upon their respective lands described under their
19 respective names in Schedule 1 hereof in the proportion as follows:

26 XIX

27 All allotments hereinabove provided, which are within the same
28 priority class, are equal in priority and correlative in right and at all
29 times when the water supply available for rights within a priority class is
30 inadequate to supply all rights and allotments within said class, then during
31 the continuance of such shortage, the owners of such allotments shall prorate

1 the available water supply, if any, in excess of the quantity required for
2 prior rights, in accordance with their respective allotments for that class,
3 except as otherwise hereinbefore provided in paragraph XIV of this article.

4 XX

5 No water shall be diverted through taps on the Gee and Drider Ditches
6 by any of the parties hereto, with the exception of Grace A. Street and
7 Charlie Lee Pabst, during the period from October 15th of each and every
8 year to March 15th of the succeeding year, both dates inclusive.

9 XXI

10 It is further ordered, adjudged and decreed that each and every
11 party to this action, his or her agent, successors, grantees and assigns, be
12 and they are hereby perpetually enjoined and restrained from doing anything
13 in violation of the provisions of this decree, or diverting any water from
14 said Eagle Creek at any time in violation of the terms thereof, or from
15 diverting any of such water at any time in excess of a quantity of water
16 reasonably necessary for and being put to beneficial use, or from doing
17 anything, directly or indirectly, that will obstruct or interfere with any
18 right of another in this decree adjudged and determined.

19 XXII

20 The amount due from the parties hereto to said Division of Water
21 Resources for expenses incurred as referee shall be borne by the parties
22 hereto in accordance with the apportionment of said expenses as follows:
