This email responds to your [January 18, 2017 letter](#). You asked for information regarding the status of the State Water Board's issuance of an order.

The State Water Board held a public hearing on January 25 and 26, 2016 concerning the matter of the Draft Cease and Desist Order and Administrative Civil Liability Complaint against G. Scott Fahey and Sugar Pine Spring Water, LP (Fahey) , during which it heard testimony and received evidence. At the hearing, the State Water Board's Prosecution Team and Fahey appeared and presented case-in-chief and rebuttal testimony and exhibits. MID, TID, CCSF appeared only to participate by cross-examination or rebuttal and to present non-evidentiary policy statements. The Prosecution Team, Fahey and the Intervenors submitted closing briefs on June 17, 2016. The parties were notified on [July 5, 2016](#) that the evidentiary hearing record was closed.

The Hearing Team is currently considering all of the evidence in the hearing record. Given current priorities, the Hearing Team is working diligently to complete preparation of a Draft Order containing findings and conclusions that are based upon the hearing record. Please refer to the following [Hearing Process Flowchart](#), which describes the remaining action-steps in this process. At this time, we cannot provide you with a definite time period for issuance of a Draft , but you and the other parties will be notified once a draft order has been released by the Board.
