To Whom It May Concern,

You are receiving this letter because you have one or more water right(s) or water right claim(s) in the Fresno River Watershed on file with the State Water Resources Control Board (State Water Board or Board) Division of Water Rights. This is a follow-up to a letter sent to you in July 2019 in order to confirm the date and time of a public meeting and provide you with additional information.

The State Water Board is considering a petition submitted by Madera Irrigation District to conduct a statutory adjudication of water rights in the Fresno River Watershed. The Board will consider a draft resolution regarding the petition at a public Board Meeting on **Tuesday, September 17, 2019, at the Cal-EPA Building in Sacramento**. This item is anticipated to be addressed **no earlier than 11:00 AM**.
