SUBJECT OF THE CANCELLED HEARING

On September 28, 2007, the State Water Resources Control Board's (State Water Board) Division of Water Rights issued a Notice of Proposed Revocation based on facts indicating that the Irish Beach Water District (Permittee) has failed to commence, prosecute with due diligence, and complete the work necessary to appropriate water under Permit 16622 and has failed to apply to beneficial use all or part of the water authorized for appropriation as contemplated in the permit and in accordance with the Water Code and the regulations of the State Water Board. By letter dated October 12, 2007, the Permittee requested a hearing on the proposed revocation.

By revised Notice of Public Hearing dated December 31, 2008, the State Water Board notified the Permittee that, if the Permittee failed to submit a Notice of Intent to Appear (NOI) by the specified deadline, the State Water Board will deem their request for a hearing regarding the proposed revocation to be withdrawn and the permit may be revoked without further notice. Because the Permittee failed to submit an NOI, no hearing is required to be held on the proposed revocation of Permit 16622 and the previously rescheduled hearing is cancelled.
