STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 72-38

AUTHORIZING THE EXECUTIVE OFFICER OR CHIEF, DIVISION OF ADMINISTRATIVE SERVICES, TO EXECUTE AN AGREEMENT BETWEEN THE STATE WATER RESOURCES CONTROL BOARD AND THE UNIVERSITY OF CALIFORNIA SANITARY ENGINEERING RESEARCH LABORATORY AND ENVIRONMENTAL QUALITY ENGINEERING, INC., FOR CONDUCT OF A STUDY TO ASSESS BIOLOGICAL EFFECTS OF TREATED WASTEWATERS ON THE TRUCKEE RIVER

WHEREAS:

- 1. At least \$120,595 for research and investigation related to wastewater management planning are available in the Board's budget this fiscal year.
- 2. A study of the biological effects of a treated wastewater discharged to the Truckee River is necessary for the evaluation of alternative wastewater management systems for the North Tahoe-Truckee subbasin.
- 3. The study must be implemented immediately to provide findings that can be incorporated into the evaluation of alternative systems by the State and the Tahoe-Truckee Sanitation Agency (TTSA) planning contractors, if a project for TTSA is to be approved for 1972-73.
- 4. The study will indicate whether a highly treated wastewater can be discharged to the Truckee River without causing harmful, objectionable or nuisance biological effects and the results will be applicable to other high-elevation California streams.

THEREFORE BE IT RESOLVED:

1. That this Board enter into agreements with the following contractors for conduct of joint studies during the period and for funding from the Clean Water Bond Fund as listed:

- 3. That execution of the agreements is contingent upon an agreement between the Board and the Truckee Sanitation District for conduct of the study on property controlled by the District and use of the District's wastewater for study purposes.
