STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 86-93

ACCEPTANCE OF FRESNO COUNTY'S PHASE I 205(j)
FINAL REPORT AS COMPLETION OF THE "FRESNO WATER QUALITY
MANAGEMENT PLANNING PROGRAM"

WHEREAS:

- 1. Pursuant to the terms of the Phase I 205(j) grant from the U. S. Environmental Protection Agency (EPA), the State Water Resources Control Board (State Board) provided funds under Standard Agreement No. 3-074-225-2 to the Public Works and Development Services Department of Fresno County (County) to conduct a ground water quality management and planning project in and around the cities of Clovis and Fresno.
- 2. In addition to the County, four other local agencies, City of Fresno, City of Clovis, Fresno Metropolitan Flood Control District, and Fresno Irrigation District (Agencies), participated in the planning effort.
- 3. In completion of the 205(j) Phase I project entitled "Fresno Water Quality Management Planning Program", the County and participating Agencies submitted to the State Board the final report entitled Water Resources Management Plan for Fresno-Clovis Urban and Northeast Fresno County (Plan), June 1986.
- 4. The Plan provides monitoring and management alternatives for protection of the quality and quantity of ground water resources in the Fresno/Clovis area.
- 5. Seven Best Management Practices (BMPs), including financial and institutional implementation proposals, are proposed in the Plan. The attached BMPs meet the criteria for certification by the State Board.
- 6. The County and participating Agencies adopted the Plan by the following resolutions:
 - a. Fresno Irrigation District--Resolution 86-10, Board of Directors, July 9, 1986
 - b. Fresno Metropolitan Flood Control District--Resolution 1332, Board of Directors, July 14, 1986
 - City of Fresno--Resolution 86-348, City Council, July 22, 1986

- d. City of Clovis--Resolution 86-94, City Council, August 11, 1986
- e. County of Fresno--Resolution 86-378, Board of Supervisors, August 12, 1986

THEREFORE BE IT RESOLVED:

That the State Board:

- 1. Accepts the final report entitled <u>Water Resources Management</u>
 Plan for Fresno-Clovis Urban and Northeast Fresno County.
- Authorizes final payment to the County for work performed under Standard Agreement No. 3-074-225-2.
- 3. Certifies the seven attached measures as BMPs.
- 4. Does not make any commitments, on behalf of itself or the California Regional Water Quality Control Board, Central Valley Region, to provide funds for any aspects of implementation of the Plan.
- 5. Directs staff to transmit the Plan, including the BMPs, to EPA as completion of the 205(j) "Fresno Water Quality Management Planning Program".
