RESOLUTION NO. 92-43

APPROVAL OF STATE WATER POLLUTION CLEANUP AND
ABATEMENT ACCOUNT FUNDS FOR REGIONAL BOARD
CLEANUP AND ABATEMENT ACTIVITIES

WHEREAS:

1. The State Board approved procedures for allocating funds from the Cleanup and Abatement Account (Account) as provided in Chapter 4.4 of the State Board's Procedures Manual;
2. The Division of Clean Water Programs (Division) asked the Regional Boards that contributed to the Account, to submit the amount expended for staff costs associated with collecting fines in fiscal year 1990-1991;
3. Three Regional Boards, North Coast Region, San Francisco Bay Region, and Central Valley Region, responded to the Divisions request;
4. San Francisco Bay Region expended \$21,516 for staff costs to collect \$78,960 for the Account;
5. Central Valley Region expended \$43,811 for staff costs to collect \$260,500 for the Account;
6. North Coast Region expended \$17,250 for staff costs to collect \$38,500 for the Account; and
7. There are sufficient funds in the Account, and the State Board has stated it will attempt to reimburse the Regional Boards for staff costs associated with obtaining court-ordered fines or administrative civil liabilities.

THEREFORE BE IT RESOLVED:


That the State Board approves the following disbursement of funds from the Cleanup and Abatement Fund to be used by the respective Regional Boards for future cleanup and abatement activities:

<u>California Regional Water Quality Control Board</u>	<u>Amount</u>
North Coast Region	\$17,250
San Francisco Bay Region	\$21,516
Central Valley Region	\$43,811

However, before these funds can be allocated from the Account, each Regional Board must identify projects where the funds will be used for the purposes stated in Water Code Sections 13442 and 13443.


