NOTICE OF PUBLIC HEARING

PROPOSED REGULATION THAT PROVIDES AN INTERIM VARIANCE FROM SPECIFIC INDEPENDENT TESTING AND APPROVAL REQUIREMENTS FOR UNDERGROUND STORAGE TANK (UST) SYSTEMS STORING CERTAIN BIODIESEL BLENDS

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will hold a public hearing to accept comments on a proposed regulation that provides an interim variance from specific testing and approval requirements for UST systems storing certain biodiesel blends. A quorum of State Water Board members may be present, but no action will be taken.

The proposed regulation was made available for public comment on August 14, 2009. The hearing will be held during the State Water Board's scheduled meeting at the following time and location:

PARKING AND ACCESSIBILITY
