At the public hearing where the State Water Board considers adopting the proposed General Order, interested persons will have an opportunity to comment on the proposed action. To ensure a productive and efficient meeting in which all interested persons have an opportunity to participate, oral comments at the hearing may be time-limited.

There will be no sworn testimony or cross-examination of interested persons, but the State Water Board and its staff may ask clarifying questions. The State Water Board may consider and adopt changes to the proposed General Order consistent with the purpose of the General Order.

This item is subject to the ex parte communication disclosure requirements of Water Code section 13287, as explained in a [Memo from the Office of the Chief Counsel \(http://www.waterboards.ca.gov/laws_regulations/docs/exparte.pdf\)](http://www.waterboards.ca.gov/laws_regulations/docs/exparte.pdf).

Any communications between interested persons and board members (other than at a noticed board meeting or submitted as a comment letter in compliance with the public notice) must be disclosed by the interested person within seven days of the communication. 
