PURPOSE & AGENDA

RACIAL EQUITY LISTENING SESSIONS

The Water Boards are hosting a series of four listening sessions to empower members of the public to share their perspectives and provide input on priorities for addressing racial inequities as they relate to the Water Boards and the programs we implement. The Water Boards will compile feedback from the community listening sessions, which will help inform the development of racial equity resolutions and action plans. The goal for the development of these resolutions and action plans is to ensure Water Boards priorities are advancing racial equity through our people, practices, and programs in ways that will be most beneficial to the communities we serve.

All four listening sessions will have the same agenda structure, presentation, and discussion questions. Participants will join small group discussions facilitated by Water Board staff. Guided discussion topics include, but are not limited to, community accounts and experiences of racial injustice or inequity, improving community access to our data, information and decision-making processes, capacity building, funding, and language access. Written notes from the discussions will be captured but will not be attributed to specific participants. To foster an environment of open and honest dialogue, the meetings will not be recorded and will not be publicly webcast. Space is limited to 50 participants for each listening session, and advanced registration is required.

BACKGROUND

The State Water Board and the nine Regional Water Quality Control Boards (collectively Water Boards) are part of the California Environmental Protection Agency (CalEPA) and are responsible for protecting water quality and water resources for the people of California. The Water Boards acknowledge they have a critical role to ensure racial equity when implementing the Water Boards' mission: "To preserve, enhance, and restore the quality of California's water resources and drinking water for the protection of the environment, public health, and all beneficial uses, and to ensure proper water resource allocation and efficient use, for the benefit of present and future generations."

The Water Boards are committed to advancing racial equity internally at the Water Boards and externally for the communities they serve. The Water Boards have established a Racial Equity Steering Committee and Racial Equity Working Group to address systemic, institutional, and individual racism at the Water Boards and to address racial inequities in the communities we serve. The Racial Equity Steering Committee and Working Group are developing a robust and inclusive Racial Equity Initiative that aims to ensure that all Water Boards programs and policies protect public health and the environment equitably, regardless of race.

PUBLIC COMMENT

These meetings are open to the public and will involve facilitated discussions with members of the public and an opportunity for open dialogue. Members of the public will be provided an opportunity to discuss agenda items via videoconference or telephonically. There is no need to submit public comments ahead of the meeting.
