#### **Regarding the Draft 2022 Special Report of the Statewide Advisory Committee on Cooling Water Intake Structures**

#### **BACKGROUND**

The Statewide Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (Once-Through Cooling Policy or OTC Policy) requires that the SACCWIS convenes periodically to ensure that implementation of the OTC Policy will not cause disruption in the State of California's electrical power supply. All meetings of the SACCWIS are open to the public.

The meeting will include a presentation and the Committee's consideration of approval of the Draft SACCWIS Report, including a recommendation to extend the OTC Policy compliance dates for Alamitos, Huntington Beach, and Ormond Beach generating stations until December 31, 2026, to respond to Assembly Bill 205 and the associated establishment of the Electricity Supply Strategic Reliability Reserve Program. The SACCWIS will also consider providing support for a request from the Los Angeles Department of Water and Power to extend the OTC Policy compliance date for Scattergood Generating Station until December 31, 2029, to support local grid reliability.
