# Draft Amended Proposition 1 Groundwater Grant Program Guidelines BACKGROUND

The Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1) was approved by California voters on November 4, 2014. Proposition 1 authorizes \$720 million to the State Water Board to provide competitive grants for projects that prevent or clean up contamination of groundwater that serves or has served as a source of drinking water (California Water Code § 79771). The State Water Board set aside \$144 million for projects serving disadvantaged communities (DACs)/economically distressed areas (EDAs) and will ensure that at least \$72 million of those funds go to projects that serve severely disadvantaged communities (SDACs) (Water Code section 79774(d)).

The <u>Proposition 1 Groundwater Grant Program</u> (Prop 1 GWGP) Guidelines (Guidelines) were adopted on May 18, 2016 (<u>Resolution No. 2016-0028</u>) and amended on December 19, 2017 (<u>Resolution No. 2017-0075</u>) and February 2, 2021 (<u>Resolution No. 2021-0003</u>). The Guidelines outline the process to solicit applications, criteria to evaluate and select eligible proposals, and requirements that apply to funded projects.

The Prop 1 GWGP has funded two rounds of projects (Round 1 and Round 2), leaving \$102.2 million for a third round of funding (Round 3). The State Water Board's Division of Financial Assistance (DFA) solicited proposals for Round 3, and the Round 3 solicitation closed on July 15, 2022. Full proposals were reviewed and scored by technical experts from DFA, the Regional Water Quality Control Boards, the Division of Drinking Water, and the Department of Toxic Substances Control. Based on the technical experts' recommendations, the Deputy Director of the DFA approved preliminary funding awards, totaling approximately \$52.9 million, for eight projects.

Execution of the Round 3 funding agreements will exhaust the DAC set-aside funds; however, approximately \$21.8 million will be left in the SDAC set-aside, and approximately \$27.5 million will be left for all GWGP-funded and co-funded projects regardless of DAC status (approximately \$49.3 million total remaining).

The remaining \$49.3 million in funds will be used to provide additional funds for existing or Round 3 projects and to fund Drinking Water Treatment or Wastewater projects that serve SDACs. The current Guidelines authorize the Deputy Director of DFA to reduce the match funds requirement for projects that clean up or prevent the contamination of an aquifer and serve DACs, SDACs, or economically distressed areas as defined therein. The Draft Amended Guidelines would authorize the Deputy Director of DFA to completely waive the match requirements for Round 3 projects benefiting DACs and SDACs and future additional funding requests from projects that serve DACs and SDACs, to the extent authorized by statute. The Draft Amended Guidelines also clarify the language regarding the Drinking Water Treatment and Wastewater Projects, update the technical assistance set-aside section, and provide minor updates throughout the document.
