## NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND BOARD WORKSHOP ON A DRAFT WATER QUALITY CONTROL POLICY FOR STANDARDIZED COST REPORTING IN MUNICIPAL STORMWATER PERMITS

**NOTICE IS HEREBY GIVEN THAT WRITTEN COMMENTS WILL BE ACCEPTED** by the State Water Resources Control Board (State Water Board) on the proposed Draft Water Quality Control Policy for Standardized Cost Reporting in Municipal Separate Storm Sewer System (MS4) Permits (Draft Municipal Stormwater Cost Policy) and the proposed Draft Municipal Stormwater Cost Policy Staff Report (Staff Report).

A quorum of the State Water Board will attend the workshop; however, no State Water Board action will be taken on the Draft Municipal Stormwater Cost Policy.

**POLICY OVERVIEW:** The Strategy to Optimize Resource Management of Stormwater (STORMS) staff has developed the Draft Municipal Stormwater Cost Policy that identifies statewide cost reporting requirements for Phase I and traditional Phase II MS4 permittees (Permittees). If adopted, the policy would require Permittees to use a list of standardized cost categories to track their MS4 permit implementation costs. In addition, the policy would require Permittees to report annual expenditures for implementing their MS4 permits using a statewide cost submittal tool. The goal of the proposed policy is to increase the understanding of true costs associated with various MS4 permit elements and inform future permit requirements.

**WORKSHOP OVERVIEW:** STORMS staff will present an overview of the Draft Municipal Stormwater Cost Policy and standardized cost categories for reporting MS4 permit implementation costs, cost tracking, and reporting of cost data. The workshop will include opportunities to provide feedback. To ensure all interested parties have an opportunity to participate, oral comments may be time limited.

Comments heard at the workshop and submitted in writing by the above deadline will help inform revisions to the proposed Draft Municipal Stormwater Cost Policy. Staff encourages commenters to provide input now to help inform the policy making process. A revised Draft Municipal Stormwater Cost Policy will be released for an additional public comment period prior to the public hearing.
