Background

The Santa Ana Regional Water Quality Control Board (Santa Ana Regional Board) is seeking a State Water Board resolution that authorizes a supplemental environmental project (SEP) program that funds regional monitoring programs (RMPs) in accordance with Section VIII.H. of the State Water Board's Policy on Supplemental Environmental Projects (SEP Policy). This proposed Resolution would allow the Santa Ana Regional Board to enter into administrative civil liability and mandatory minimum penalty settlements that would fund SEPs supplementing Southern California Coastal Water

Research Project's (SCCWRP) coastal and watershed RMPs for monitoring that dischargers within the Santa Ana Region are not otherwise legally required to perform. All monitoring is approved in advance by the SCCWRP Commission, of which both the State Water Board and the Santa Ana Regional Board are members.
