The California Environmental Protection Agency (CalEPA) Vapor Intrusion Workgroup (CalEPA VI Workgroup or Workgroup) is pleased to host five virtual public workshops to share and gain input on CalEPA's efforts to address vapor intrusion at contaminated sites from February through June 2026.

## **Vapor Intrusion Data**

This workshop will build on the previous workshops in CalEPA's Vapor Intrusion Workshop series and provide a deeper dive into vapor intrusion data by:

1. Emphasizing why robust vapor data collection is needed to support risk-based decision making,
2. Discussing the complexities of vapor data analysis,
3. Reviewing how vapor data are managed in GeoTracker and EnviroStor, and
4. Sharing CalEPA's next steps with vapor intrusion data.

The workshop will include presentations from CalEPA staff and environmental cleanup practitioners highlighting vapor data collection methods; the importance of data quality considerations; and constraints on data analysis due to data limitations. It will also provide an overview of vapor intrusion data in EnviroStor and GeoTracker, including best practices and key functionalities for submitting electronic laboratory data and completing the Building Form in GeoTracker's upload portal.

This session will build upon the information discussed in the previous workshops by incorporating elements of a robust conceptual site model and critical lines of evidence (both quantitative and qualitative) to support data collection. Attendees will have the opportunity to engage with environmental cleanup practitioners and regulators on current challenges and lessons learned around these topics during the workshop's question and answer (Q&A) portions.

## **Background**

The CalEPA VI Workgroup is a multi-agency workgroup consisting of DTSC, the State Water Resources Control Board (State Water Board), multiple Regional Water Quality Control Boards, and the Office of Environmental Health Hazard Assessment (OEHHA) that serves as a technical and regulatory resource for addressing contaminated sites impacted by vapor intrusion across California. The CalEPA VI Workgroup is hosting this 2026 Vapor Intrusion Workshop Series to present and gather feedback on its efforts and approaches to addressing and managing vapor intrusion.

The five workshops cover a wide range of topics, including introductory training on vapor intrusion, taking a deep dive into vapor intrusion in the community including collaborative engagement, and technical presentations and discussions on a holistic approach to managing vapor intrusion sites. The technical sessions will cover development of conceptual site models, paths to site closure, collective decision-making, and vapor intrusion data in GeoTracker and EnviroStor.
