The public hearing described in the July 7, 2020 Notice of Public Hearing and Pre-Hearing Conference (Hearing Notice) and the July 15, 2020 Notice of Rescheduling is postponed. The hearing will not occur on September 29 and 30, 2020, but October 22, 2020 is being held in reserve and may be used for a rescheduled hearing date. Further notification will be provided when the hearing is either rescheduled or cancelled.

On September 17, 2020, Amador Water Agency and the Department of Water Resources jointly filed a protest withdrawal agreement and request for status conference. In light of this agreement and a similar agreement between Amador Water Agency, Jackson Valley Irrigation District, and the East Bay Municipal Utility District filed on September 9, 2020, Hearing Officer Maguire has postponed the hearing and granted the request for a status conference.
