Purpose:	North Coast Regional Water Quality Control Board staff will describe a workplan to implement the North Coast Regional Water Quality Control Board's basin planning projects related to (a) assessing climate change vulnerability of beneficial uses and (b) creating a process for designating Outstanding National Resource Waters. Core to these projects is a reproducible, transparent, and interactive tool that allows staff and the public to perform their own assessments using readily available data. The workplan comprehensively describes the necessary tasks (as envisioned by North Coast Water Quality Control Board staff) to create such a tool.		
Desired Outcome:	North Coast Water Board staff would like to have Water Quality Monitoring Council participants be involved in this project as a scientific and technical advisory committee, especially during the literature review phase where methods, metrics, and indicators will be evaluated for inclusion in the tool. Monitoring Council participants may also consider being involved more directly, such as committing staff and other resources to accomplish tasks outlined in the workplan.
