### State Water Resources Control Board March 19, 2013 Item 7 - Executive Director's Report

## **DIVISION OF WATER QUALITY**

<u>CalRecycle Transfer Station Regulations – Anaerobic Digesters</u>: On February 20, 2013, State Water Board, CalRecycle and California Association of Sanitation Agencies staff met to discuss regulations being developed by CalRecycle pertaining to anaerobic digestion. The issue discussed was providing an exclusion from waste transfer permitting requirements for injection of fat, oil, grease and food processing waste into anaerobic digesters at Publicly Owned Treatment Works (POTWs). Also discussed was a potential exclusion for dedicated digesters located at POTWs that digest only hauled in waste without co-digestion with sewage sludge, thereby producing a more marketable "organic" product. The intent of the exclusion is to eliminate redundant cross-media regulation.

**Irrigated Lands Regulatory Program:** On February 5, 2013, Irrigated Lands Regulatory Program (ILRP) staff attended a California Department of Food and Agriculture (CDFA) meeting on the Food Safety Modernization Act (FSMA). ILRP staff will work with CDFA staff to review and comment on the FSMA.

On February 7, 2013, ILRP staff participated in a national webinar to discuss how to improve collaboration between state water agencies and the Natural Resource Conservation Services (NRCS). The focus of the meeting was on how the agencies can use their expertise to assist agricultural growers to meet water quality objectives.

On February 8, 2013, ILRP staff participated in a California Roundtable for Agriculture and the Environment (CRAE) monthly conference call. The main discussion items were on the development of water quality principles and the 2013 CRAE work plan.

On February 14, 2013, ILRP staff participated in a climate action team - agricultural sector meeting to discuss development of a climate change scoping plan. CDFA is the lead agency.

On February 14, 2013, ILRP staff participated in a Farm, Food Safety, and Conservation Network meeting to discuss planning an annual conference. Also discussed were proposed revisions to the FSMA and the potential impact the revisions may have on the agricultural community and agricultural related water quality regulatory programs.

On February 20, 2013, ILRP staff participated in a meeting with the California Bioresoures Alliance (CBA) planning subgroup to discuss the CBA annual symposium to be held in September 2013 at the Cal/EPA building.

On February 21, 2013, ILRP staff met with U.S. Environmental Protection Agency (U.S. EPA) and NRCS to select projects to be funded by the National Water Quality Initiative (NWQI).

On February 28, 2013, State Water Board staff participated in a meeting with U.S. EPA to discuss the use of State Revolving Fund (SRF) dollars to fund agricultural related best management practices (BMP) in Merced County.

**Nitrate Pilot Projects in the Tulare Lake Basin and Salinas Valley:** On February 20, 2013, the State Water Board released the final report to the legislature, "Recommendations Addressing Nitrate in Groundwater." The report was required by Senate Bill X2 1 (Perata, 2008). This required the State Water Board and other agencies to develop pilot projects in the Tulare Lake Basin and the Salinas Valley to study nitrate contamination, identify remedial solutions and funding options to clean up groundwater. **Desalination Policy:** A State Water Board Workshop was held on August 22, 2012, to present results and recommendations from the three studies. Staff held a stakeholder meeting with the ERP members and the public on January 30, 2013 to discuss scientific issues associated with desalination entrainment. Staff anticipates public release of the amendments in spring 2013 with a State Water Board hearing in December 2013.

<u>Once-Through Cooling (OTC)</u>: Staff has been working with the Interagency Working Group to review implementation plans from the power plant operators, and the grid reliability studies submitted by the Los Angeles Department of Water and Power and the Cal Independent System Operator. This information will be discussed by the Statewide Advisory Committee for Cooling Water Intake Systems at its April meeting. **Salt/Nutrient Management Planning:** On February 13, 2013, the State Water Board and Regional Water Board staff held a Web meeting to update the statewide salt/nutrient management plan (SNMP) development tracking system, share the results of the State Water Board's February 2013 report to the Legislature, *Recommendations Addressing Nitrate in Groundwater in the Tulare Lake Basin and Salinas Valley*, and stay current with SNMP development progress for each region. On the same day, the Groundwater Resource Association, CalDesal Association, and Association of California Water Agencies held a webinar that featured State Water Board Vice-Chair Frances Spivy-Weber as a speaker on approaches for developing SNMPs. During the March 5, 2013, State Water Board meeting, Regional Water Board Executive Officers or their designees presented SNMP progress reports. On March 17, 2013, State Water Board staff presented a summary of SNMP components and current statewide SNMP development progress at the WateReuse Association annual conference.

Sanitary Sewer System Waste Discharge Requirements (SSS WDRs): Based on stakeholders' comments and management direction, staff has updated the SSS WDRs' Monitoring and Reporting Program (MRP) and requested additional written comments from stakeholders on January 7, 2013. Staff received 43 comment letters and is in the process of revising the MRP in response to the comments. Additionally, staff met with stakeholder representatives to address concerns raised in the comment letters on January 30, 2013. Staff anticipates re-issuance of the MRP by the Executive Director in April 2013. **Sediment Quality Objectives, Phase II:** Staff is working with the Los Angeles Regional Board and the Ports of Los Angeles and Long Beach to collaborate on studies that will assist in the development, testing and implementation of Phase II SQOs. A harbor technical workgroup meeting took place on February 22, 2013.

**Storm Water Construction General Permit:** On November 14, 2012, the California Coastkeeper Alliance (CCA) filed a suit challenging the construction storm water permit (which was amended on July 17, 2012) on the grounds it did not include numeric effluent limitations. CCA is arguing that the State Water Board did not include U.S. EPA narrative effluent limitation guidelines for construction and development and did not conduct the required analysis. Staff is working with the Attorney General's office in preparing for the hearing(s). Staff is also preparing to establish a self-directed training option parallel to the QSD/QSP program for California-licensed professionals regulated by the Department of Consumer Affairs.

**Storm Water Industrial General Permit:** Staff has been evaluating the public comments received on the latest draft of the permit (due October 2012) and anticipates releasing a new, final draft in April of 2013. No adoption meeting has been scheduled at this time but is anticipated to be considered by the Board in July 2013.

**Suction Dredging Update:** In a letter dated February 7, 2013, the Department of Fish and Wildlife consulted the State Water Board in accordance with Fish and Game Code section 5653.1(c)(1). The State Water Board responded to this consultation request in a letter dated March 11, 2013. This letter is available

<u>Trash – Amendments to Statewide Plans</u>: Staff continues to work with the Public Advisory Group (PAG) to develop a policy to address trash in waters of the State. The PAG consists of 10 individuals who have knowledge and expertise relative to trash and debris. A preliminary draft Staff Report/Substitute Environmental Document (SED) has been prepared by Tetra Tech and staff, and sent to the PAG. A PAG meeting was held on August 13, 2012 to discuss the changes and recommendations. The draft policy was release to the PAG for discussion and recommendations. A PAG meeting was held on March 6, 2013. The target for release of the Draft SED and amendments for public comment is in the spring of 2013.

<u>Statewide Policies/Significant General Permits</u>: Appendix 1 provides the current status of Statewide Policies and Significant General Permits.

<u>UST Cleanup Program Agency Status Report</u>: Underground Storage Tank (UST) cleanup program data is stored in a publicly accessible database known as GeoTracker. U.S. EPA downloads data from GeoTracker and prepares a semi-annual report on the status of the UST cleanup program that includes information on the number of active and closed cases as well as other data. In addition to case closure rate and other statistics, this report includes a new Table B (page 7) that summarizes the status of UST Case Closure Policy implementation by agency. This report is compiled semi-annually by U.S. EPA using data from GeoTracker

**Underground Storage Tank Program - Case Closures:** The Low Threat Closure Policy (LTCP) for underground storage tank cleanup sites became effective on August 17, 2012. The following tables illustrate progress that the various regulatory agencies, the Division of Water Quality and the Division of Financial Assistance are making in reviewing their respective caseloads of UST sites using the criteria contained in the LTCP. The Division of Water Quality and the Division of Financial Assistance are coordinating on the construction of a GeoTracker Report accessible to the public so that this information will be available on a real-time basis to the public in the future. This report will be available by the end of April 2013.

#### Wetland Area Protection and Dredged and Fill Discharge Permitting Policy:

Staff are currently revising the Substitute Environmental Document and also finalizing comments on the wetland definition peer review. The policy and SED are scheduled for public review in early summer 2013.

### **DIVISION OF WATER RIGHTS**

#### Water Quality Certification Issued for Sandbar Dam Weir and Cableway Project:

On February 28, 2013, the Executive Director issued water quality certification for the Sand Bar Dam Weir and Cableway Project (Project). The Project involves the modification of an existing weir and construction of a cableway on the Middle Fork of the Stanislaus River (MFSR). Modifications to the weir and installation of a cableway will allow for accurate monitoring of flows in the MFSR. Monitoring of minimum instream flows downstream of Sand Bar Dam is required per the license requirements associated with the Spring Gap-Stanislaus Hydroelectric Project (Federal Energy Regulatory Commission Project No 2130). The water quality certification was issued to ensure the Project will comply with the Clean Water Act and other requirements of state law. **Interagency Instream Flow Workgroup Meeting:** On February 27, 2013, Division of Water Rights staff met with staff from the California Department of Fish and Wildlife (CDFW; formerly known as California Department of Fish and Game), United States Fish and Wildlife Services (USFWS), and the State Coastal Conservancy (SCC). Topics covered at the meeting include: updates from each of the agencies, an overview of the status of planned and upcoming instream flow studies and recommendations, an overview of the 2008 CDFW Historical Flow Recommendations Summary Report, and a discussion of coordination on various instream flow-related efforts. The next quarterly Interagency Instream Flow Workgroup meeting is tentatively scheduled for May 2013.

### **DIVISION OF FINANCIAL ASSISTANCE**

#### **Program Activity:**

#### **Cleanup and Abatement Account:**

• 13 disbursements were made in the month of February totaling \$431,478.

#### Site Cleanup Program:

• A total of \$139,710 was collected during the month of February.

#### USTCF:

- On March 1, 2013 the Underground Storage Tank Cleanup Fund released a Payment Processing Improvement Plan. This Plan describes various steps the Cleanup Fund has recently implemented and will implement, to improve payment processing times. <u>Clean Water State Revolving Fund (CWSRF)</u>: Between February 4, 2013 and March 6, 2013, the Deputy Director of DFA approved the following Preliminary Loan/Grant Commitments:

- On February 14, 2013, Determination No. 2012-35 approved \$335,000 in CWSRF Small Community Grant funds for the Murphys Sanitary District, for planning financing for their Wastewater Treatment Facilities Improvement Project; CWSRF No. C-06-7849-110.
- On February 13, 2013, Determination No. 2012-02 approved \$30,000,000 in Loan Commitment funding from the CWSRF Program to expand EI Toro Water District's recycled water treatment plant and distribution system; CWSRF No. C-06-5006-110.

## OFFICE OF DELTA WATERMASTER

Settlement Agreement on Cease and Desist Order for Violation of Annual Reporting: In March 2012, the State Water Board sent notification letters to water right diverters to submit their 2011 annual or triennial water use reports by July 1, 2012. In August 2012, the State Water Board Delta Watermaster mailed delinquency letters to diverters in the Delta who did not submit their 2011 water use reports by July 1, 2012. The Delta Watermaster mailed out Notices of Cease and Desist Order (CDO) in October and November 2012 to Delta diverters for failure to file their 2011 annual use reports. One December 7, 2012, one water right licensee, Saybrook, requested a hearing on the November 16, 2012 draft CDO. The Delta Watermaster issued a Decision approving a settlement agreement between this Saybrook and the Delta Watermaster on March 4, 2013 on the draft CDO and annual reporting requirements.

**Free Calendar Available from the Water Board's Clean Water Team:** Celebrate a year of clean water and citizen monitoring. Created by the Clean Water Team the 2013 California Citizen Monitoring Calendar highlights the importance of California's surface waters, and celebrates the state's citizen monitors who volunteer to improve and protect water quality by using applied science to monitor the state's waters. The calendar is fully hyperlinked so you can click on a picture or event to learn more about a specific event, commemoration, citizen monitoring organization, agency or internet available resource.

The calendar features images of volunteers in action that were provided by citizen monitoring programs. California's citizen volunteers work through a variety of organizations to monitor water quality in streams and rivers throughout the state. Community and resource managers use monitoring information to better protect California's waters. Prior calendars have proven to be useful tools for these citizen monitors and watershed stewardship organizations. It aids their event planning, outreach and environmental education efforts, volunteer recruitment functions, fundraising activities and more.
