R3-2017-0020; GENERAL WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES OF WINERY WASTE AND CATEGORICAL WAIVER OF WASTE DISCHARGE REQUIREMENTS AND WAIVER OF REQUIREMENT TO SUBMIT REPORT OF WASTE DICHARGE FOR CERTAIN SMALL WINERIES, CENTRAL COAST REGION

On September 21, 2017, the Central Coast Water Board approved *Order No. R3-2017-0020*, General Waste Discharge Requirements for Discharges of Winery Waste and Categorical Waiver of Waste Discharge Requirements and Waiver of Requirement to Submit Report of Waste Discharge for Certain Small Wineries (General Winery WDR), Central Coast Region.
