NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT NO.  
CA0048551 – MONTEREY ONE WATER REGIONAL WASTEWATER TREATMENT PLANT  
AND ADVANCED WATER PURIFICATION FACILITY, MONTEREY COUNTY**

At its public meeting on December 6, 2018, the Central Coast Regional Water Quality Control Board adopted Order No. R3-2018-0017, Waste Discharge Requirements for the Monterey One Water Wastewater Treatment Plant and Advance Water Purification Facility located at 14811 Del Monte Boulevard, Marina, Monterey County.
