WOODLANDS MUTUAL WATER COMPANY, ARROYO GRANDE, SAN LUIS OBISPO COUNTY – ADOPTION OF WASTE DISCHARGE REQUIREMENTS, WATER RECYCLING REQUIREMENTS, AND MONITORING AND REPORTING PROGRAM - ORDER NO. R3-2018-0002

This letter advises you that the Central Coast Regional Water Quality Control Board adopted Waste Discharge Requirements, Water Recycling Requirements, and Monitoring and Reporting Program Order No. R3-2018-0002 at its regularly scheduled meeting on June 28, 2018 in Santa Barbara. You may download the new Order and Monitoring and Reporting Program from our website at:

The new Order supersedes Order No. 00-139 which is now terminated, and Woodlands enrollment in general water recycling Order WQ 2016-0068 is canceled.

Please review the new Order and Monitoring and Reporting Program and ensure that you understand all new requirements, including a study analyzing the steps to be taken to reduce Total Dissolved Solids (due July 2019) and the installation of 4 new groundwater monitoring wells, to be completed by July 29, 2019. Additionally, the point(s) of compliance for Total Dissolved Solids concentration is now located within each reclaimed water storage unit at the Woodlands development.
