CHAIR Awards -> Please Pass on to BOARD & STAFF

in early February, 2001, Robert A Stark, a retired chemical engineer told me, "i've been testing my well water for over 30 years and they're lying about the water here." it was what i call a "reverse Erin Brockovich moment". for over a year, i wrote, called, sued (CV 10500) to find out the Truth. in May, 2002, i was at my hairdresser in Baywood Park. i got a call saying the California Highway Patrol had visited my Home, looking for me. Horror of Horrors! when i called their office, i was told it was because of a "complaint by a guy named Hubner"

as i spoke with the (2 cars full of) CHP officers in front of my residence, i was struck with the Enormity of the Situation:

2 and a half months before, i'd sent one of 18 requests for GROUNDWATER MONITORING DATA from the RWQCB. this particular time, my handwritten plea was on the back of 3 pages from my self-published book, "Peace Works". in my Enthusiasm, i'd had it translated into French, Spanish and Japanese...to further "get the Message out". i ran out of money for binding and was using it for correspondence. the backs of 2 pages were in Japanese...the 3rd, Spanish. it was a quote, en-Espanol, by Cyndi Lauper: "the ramifications of Death are, like final"

after all this time, Gerhardt Hubner, under the direction of Roger W Briggs, decided this quote on the backside of a request for GROUNDWATER MONITORING DATA FOR LOS OSOS/BAYWOOD PARK was a "Terrorist Death Threat against a CA state employee". the CHP officers were embarassed and apologetic when i showed them my swell little book.

however, it doesn't reduce the Fear i experienced as it dawned on me that i could be shot dead in my driveway, reaching in my pocket for a kleenex.

i sent mr hubner a copy of "Peace Works". i never heard from him. the case was called, "unfounded" and, allegedly, cannot be accessed by anyone. subsequent requests for GROUNDWATER MONITORING DATA to the RWQCB were answered by someone else, always with a "CC" to "CHP".

to my knowledge and according to EVERYONE else i've EVER talked to, there's NEVER, EVER BEEN ANY GROUNDWATER MONITORING DATA FOR LOS OSOS revealed by the RWQCB.

Sorrel Marx (RWQCB employee) stated in early 2001, "the septics are failing in Los Osos". this is also remarkable since NO SEPTIC SURVEY HAS EVER BEEN DONE IN LOS OSOS/BAYWOOD PARK.

here's something i composed to try to relieve my anxiety about the aforementioned Event:

"herr hubner called the CHP to chase around my town. we want answers to our questions and we will/wack you down. you threatened death, you terrorist, albeit it quite discrete.
