Before Senator Blakeslee has even begun to mediate, CSD President Shicker is stating that the sewer is non-negotiable(see enclosure from the SLO Tribune). This statement while millions of dollars of pipes and materials are left to rot in 3 staging areas(please see enclosed pictures). Contractors and their workers are left sitting while the low interest state loan is being lost due to the illegal work stoppage. Now they are talking about other loans at 5% or more.

We have tried to remind the new board that the Tri W project was approved by state boards, the Coastal Commission and other responsible commissions. The illegal work stoppage by the new CSD board is resulting in \$200,000 a day fines. What is even worse is that in closed sessions the current board is hiring a general manager Dan Bleskey from out of town at approximately 2 times the salary of the previous manager. Also a new legal counsel John McClendon from out of town who will cost the taxpayers \$240.00 an hour. This is not fiduciary responsibility. The board should be fined and this project should go back to the county. I have written to you before asking for help but wanted you to see the pictures. Also, a response to me from a request for public records.
