### REVIEW OF WATER QUALITY CONTROL PLAN (BASIN PLAN) TRIENNIAL REVIEW PRIORITY LIST

The Regional Water Quality Control Board (Central Coast Water Board) is beginning the process of reviewing its *Water Quality Control Plan (Basin Plan) Triennial Review Priority List*. This Basin Plan serves as the cornerstone water quality protection policy for the Central Coast. It identifies beneficial uses of surface and ground waters, establishes water quality objectives to protect beneficial uses, and provides an implementation plan to achieve those objectives.

Central Coast Water Board staff has prepared a tentative list of water quality issues or a "Draft 2005 Triennial Review Priority List."

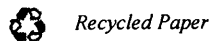
