### STATE REVOLVING FUND LOAN PROGRAM, FISCAL YEAR 2005-2006, INPUT FOR PROJECTS FOR PRIORITY LIST

State Water Resources Control Board plans to resume commitments to State Revolving Fund (SRF) loans after leverage bonds are sold in May 2005. We are requesting information about your water quality projects for placement on the SRF Loan Program's Priority List. Attached for your convenience is the most recent *Project Priority Ranking Report for State Fiscal Year 2005-2006* (Attachment 2).

Please submit new or updated information regarding projects for which you propose to seek funding from SRF as soon as possible, but no later than **February 17, 2005**. Proposals submitted for 1) reevaluation of an already listed project's priority class rank, or 2) as a new project, must include a thorough project summary and a completed "SRF Project History/Information Sheet" (Attachment 3). Projects proposed for ranking as Class A or B must also include adequate documentation of an existing public health or water quality problem. Class A, B, or C project proposals should include a signed copy of a Regional Water Quality Control Board enforcement action, including the accompanying staff report.

In addition to projects addressing water pollution from point sources, we strongly encourage proposals of projects that address nonpoint sources and storm water pollution. If you know of any other persons or agencies that might be interested in SRF funding, please forward this information to them.
