Item #14 - Dynegy Moss Landing - Oppose Permit

Dear Chair Young, Board Members, Mr. Schwartzbart, and Staff:

Monterey Coastkeeper opposes the proposed 5-year renewal of exemptions from the Toxic Pits Cleanup Act for the metal cleaning ponds at the Dynegy power plant facility at Moss Landing.

Due to problems with noticing and comment deadlines we suggest that Dynegy be given a one-year extension and the project be re-noticed and re-examined. We also believe staff should reconsider the monitoring results and methods used to establish concentration limits.

As noted in the staff report, Dynegy published notice in the Salinas Californian advertising that this matter would be heard by the RWQCB at its regular meeting in <u>September</u>. <u>No notice</u> appears in the public notice section of the RWQCB website. Written public notice was mailed to the Monterey Coastkeeper and says that written comment will be taken until <u>noon</u> on August 31. The staff report for this item gives <u>no time</u> on August 31 as a cutoff (comment is generally accepted until 5pm). <u>To act on this item is to take action before the media advertised deadline</u> of September and before the Board's own comment deadline.

The Monterey Coastkeeper, like the RWQCB, believes in good public process. However, over the past year:

- we have seen numerous stormwater plans approved with scores of unwritten, yet to be negotiated, required changes. This process undermines the public's ability to review and comment on stormwater plans.
- staff is currently reviewing a 401 Certification for 100 miles of Salinas River channel bulldozing that is based on a cursory and inadequate environmental document (RWQCB staff, State Lands, and the Air Pollution Control District agree and have provided written comment to Monterey County saying as much). But in order to allow the bulldozing to continue, staff is considering administratively extending a previous 401 Certification that is based on an even weaker environmental document. This potential administrative extension would completely end-run appropriate CEQA process.

The Monterey Coastkeeper believes it is entirely inappropriate for the Board to approve a five-year permit before the public has the opportunity to comment.

Public notice for this item or the staff report did not include any monitoring data or link to the monitoring data. A quick review of the monitoring data shows incredible variability in test results for many test parameters including pH, chloride, magnesium, sulfate, bromide, and an incredible spike late last year in ammonia. As these ponds are used intermittently, we

do not find variable data reassuring. This data is shown in Section 2 of the Q1 2009 monitoring results.

Field Parameter Trend Graph



Monitoring Parameter Trend Graph



Monitoring Parameter Trend Graph




Section Six of the monitoring report appears to rely on statistically significant increases in parameters to indicate a potential problem. We would suggest that given the variability of the data, this could be an inappropriate measure of compliance and success. The report does note a statistically significant and confirmed spike in iron.

And finally, we are disturbed by the shifting baseline. We do not fully understand the methodology, but it appears there is a process for updating concentration limitations. Nearly without exception, proposed limits for 2009 are <u>much</u> higher than previous limits. This appears to be driven by the variability of the data (that could be explained by the intermittent use of the ponds). See Monitoring results Appendix A, table 3.

The Monterey Coastkeeper believes in good process and though and timely review of permits. We do however recognize that scheduling comment of this item and this meeting date has been confused by furloughs and problems not of the Board's making.

We believe a resolution approving a one-year extension is appropriate.

We believe it is entirely inappropriate for this item to be given a five-year extension by placing it on the consent agenda of a telephone meeting occurring before the comment period even closes. (Although we fully admit that this will likely be the only comment you receive.)

The Moss Landing Power Plant facility sits literally on the bank of an important estuarine ecosystem. Moss Landing Harbor has many impairments. This permit deserves more scrutiny and discussion.
