### SUMMARY

On December 17, 2008, the Assistant Executive Officer, on behalf of the Central Coast Water Board's prosecution team, issued Administrative Civil Liability (ACL) Complaint No. R3-2008-0074 (Complaint) to the California Men's Colony (Discharger). The Complaint alleged that the Discharger violated its NPDES Permit by violating total chlorine residual effluent limitations 20 times from July 1, 2006 to August 31, 2008. The Complaint preposed that the Discharger be assessed civil liability in the amount of \$140,000.

On December 26, 2008, the Water Board's advisory team (Counsel Frances McChesney and Executive Officer Roger Briggs) notified the Discharger that it would present an order to the Water Board on February 6, 2009 (hearing date subsequently changed to the 5th), unless the Discharger waived its right to a hearing and paid the proposed penalty. As of the date of this report, the Discharger has not waived its right to a hearing or paid the proposed civil liability. In a letter to the Discharger dated December 17, 2008, the prosecution team notified the Discharger to provide any written comments, arguments, and evidence by January 12, 2009. The prosecution team will submit its written evidence to the advisory team on the same date. Those materials are attached.

Attached to this staff report are the Complaint and a draft ACL order.

#### RECOMMENDATION

The advisory staff will present its evaluation and recommendation at the hearing.
