NOTICE OF PUBLIC HEARING

To Consider Adoption of a Total Maximum Daily Load for Diazinon and Additive Toxicity with Chlorpyrifos in the Arroyo Paredon Watershed, **Santa Barbara County**

The California Regional Water Quality Control Board Central Coast Region (Central Coast Water Board) will hold a public hearing to consider approval of a resolution to adopt a Total Maximum Daily Load (TMDL) for Diazinon and Additive Toxicity with Chlorpyrifos in the Arroyo Paredon Watershed (Resolution R3-2013-0004).

The purpose of the TMDL is to protect waters within the Arroyo Paredon Watershed from water quality degradation due to elevated levels of diazinon. The resolution proposes numeric targets to protect beneficial uses, assigns allocations to achieve the numeric targets, and outlines an implementation and monitoring plan to gauge the success of achieving the TMDL. Components of the TMDLs are written in the Project Report.

Interested persons may attend and orally comment at the hearing to consider the proposed resolution to adopt a TMDL for Diazinon and Additive Toxicity with Chlorpyrifos in the Arroyo Paredon Watershed. Oral comments should be brief (less than 3 minutes) to allow all interested persons time to be heard and should summarize written comments that have been submitted. The Central Coast Water Board may consider this item at any time during the meeting.

Interested persons may submit written comments. Persons wishing to submit written comments on the proposed resolution to adopt a TMDL for Diazinon in the Arroyo Paredon Watershed must submit comments in writing to the Central Coast Water Board at its office in San Luis
