**NOTICE IS HEREBY GIVEN THAT** the Central Coast Regional Water Quality Control Board (Central Coast Water Board) will accept comments on a proposed amendment to the *Water Quality Control Plan for the Central Coastal Basin* that would establish Total Maximum Daily Loads for toxicity and pesticides in the Santa Maria watershed in Santa Barbara, San Luis Obispo, and Ventura counties, California.

### NOTICE OF PUBLIC HEARING NOTICE OF FILING A DRAFT ENVIRONMENTAL DOCUMENT

To Consider Adoption of Resolution No. R3-2014-0009 Amending the Water Quality Control Plan for the Central Coastal Basin to Adopt Total Maximum Daily Loads for Toxicity And Pesticides in the Santa Maria Watershed River in Santa Barbara, San Luis Obispo, and Ventura Counties, California.

**NOTICE IS HEREBY GIVEN** that the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board) will hold a public hearing to consider adoption of a resolution amending the Water Quality Control Plan (Basin Plan) for the Central Coast Basin. The Basin Plan establishes measures to protect beneficial uses of waters of the state and achieve water quality objectives.

If adopted, the resolution will amend the Basin Plan by incorporating Total Maximum Daily Loads (TMDLs) for toxicity and pesticides in the Santa Maria River watershed and its tributaries.

At the conclusion of the hearing the Central Coast Water Board will consider approval of the proposed resolution.

Actions to amend the Basin Plan by the Central Coast Water Board will be taken in accordance with a regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California Environmental Quality Act (Public Resources Code, section 21000 et seq.) and with other applicable laws and regulations.

Copies of the final draft resolution and amendments to the Basin Plan (including the staff report, a substitute environmental document that includes an environmental checklist, and draft amendments for adoption) will be available on or about **January 15**, **2014**, at the following website:

Note that a separate notice for public comment was previously transmitted on January 28, 2013. The public comment period commenced on January 28, 2013, and ended on March 29, 2013. Water Board staff made substantive revisions to portions of the substitute environmental documents following the public comment period, then recirculated the documents for public comment from October 15, 2013, to November 29,

2013. Therefore, Water Board staff is not accepting further written comments at this time. Oral comments may be provided to the Water Board at the public hearing shown below.

At the conclusion of the public hearing, the Central Coast Water Board will consider certification of the substitute environmental documents and approval of the proposed amendments. The Central Coast Water Board may close the public hearing and the comment period, but consider adoption of the amendments at a later public hearing.
